Jobs still scarce

OTTAWA - The job market in Ontario's recession-bruised economy will continue to tighten this year before rebounding in 1992, a prominent research institute predicts.

The Conference Board of Canada says Ontario will suffer more than other provinces during the current recession and the number of jobs will shrink from 4.94 million last year to 4.89 million this year.

However, the board expects lower interest rates and improvements in the U.S. economy will bring a recovery in the third quarter of the year and the number of jobs available to Ontarians will bounce back next year to more than five million.

Unemployment rates will also reflect the province's economic performance, jumping to 8.3 per cent this year before slipping back to 7.89 per cent in 1992. The unemployment rate was 6.2 per cent through 1990.

Disposable income levels will follow the trend, increasing by only three per cent to \$20,258 per capita this year. But with a reversal in the province's economic fortunes next year, the figure should jump 5.7 per cent to \$21.404. In 1990, per capita disposable income increased 5.2 per cent to \$19,671.

Amnesty International is a worldwide voluntary human rights movement which works for the release of men and women imprisoned anywhere for unjust reasons, provided they have neither used nor advocated violence, said Ms. Broughton. Amnesty also works to abolish torture and the death penalty world-wide.

"Our life is so comfortable here, it is easier to ignore the torture and abuse and put it out of our minds," said Ms. Broughton. "I have come to a place in my life where I can no longer do that."

Georgetown's cell will become part of a network of small Amnestry groups which meet monthly to write letters to their adopted 'prisoner' and his or her family.

"Such persistent letter writing works," said Ms. Broughton. "Hundreds of people owe their lives and freedom to the efforts of Amnesty workers who don't give up on them."

At the first meeting of the Georgetown group, area coordinator Wilf Ruland from Waterloo will be present to explain Amnesty's ideas and methods. After that, the group will be assigned their "own prisoner."

She says through modern technology, the world has become smaller to her. "My fellow human beings are closer and they need our help."
