# Halton Blue Fins swimmers set club records in Guelph

Halton Hills Blue Fins swimmers earned a number of top finishes at the Guelph Short Course Invitational, held March 2-3, setting six club records in the process.

Alison Duby, swimming in the 10 and under group, placed first in 25 metre backstroke and 25 metre freestyle, setting club records and personal best times in each event.

Duby also earned silvers in 25 metre fly and 100 metre backstroke, placing third in 50 metre backstroke as well. She also placed fourth in 50 metre freestyle, fifth in 100 metre individual medley and sixth in 100 metre freestyle.

Leigh Shillington, an 11/12 year-old competitor finished second in 25 metre freestyle, setting club records in that race as well as the 25 metre backstroke (third place) and 25 metre fly (fourth). She also placed fourth in 25 metre breaststroke, fifth in 50 metre fly and seventh in 100 metre individual medley.

Neil Scudder, a 13/14 year-old group swimmer, set a club record time in 200 metre backstroke (240.50) for an 11th place finish. Scudder also placed eighth in 50 metre backstroke and 10th in 100 metre backstroke.

Sabrina Bassett finished sixth in 50 metre freestyle in the 13/14 year-old group and competed in 100 metre freestyle as well. Tracy Tabuchi placed eighth in 25 metre

fly and 11th in 25 metre breaststroke in the 11/12 year-old group, while Laurie-Anne Crocker also competed in the same division.
