Acton Lions club member a hero to Brampton woman

If it weren't for Dave Nakeff of Acton, a Brampton woman might now be lying in hospital in serious condition or even in a cemetery instead of being alive and healthy and able to talk about her horrible experience.

"I'm glad to be alive," said Andrea Smith, who is still recovering from the shock of having been trapped on the second floor of a house engulfed in flames.

On April 4, Ms. Smith was alone in her two-storey home, sleeping. She woke up suddenly from what she describes as an explosion and saw smoke coming from the bottom of the bedroom door.

"I knew better than to open the door," she remembers. Instead, she ran to the window and started screaming and screaming.

It was the screaming that alerted Mr. Nakeff who was in the area picking up a vehicle to two back to his Acton business, Bearly Used Auto Parts.

"I looked up and saw a woman screaming from the window, but I thought she was just screaming at somebody," he said. "When I heard someone yell that somebody should call the fire department, I took off towards the house."

He tried to get in the house by breaking a front window to unlatch the front door lock but there was so much smoke, he couldn't get in-

Then a neighbor of Ms. Smith,'s Phil Watt, brought his van up to the house and Mr. Nakeff climbed on top to help carry Ms. Smith down from the window.

"I kept telling her not to jump. - I was so scared she was going to jump," said Mr. Nakeff.

And even though there was only hard concrete below the window. jump she would have, said Ms. Smith if it hadn't been for the quick thinking of Mr. Nakeff and

her neighbors, Phil Watt and Doug Roberts.

"I was scared to death," she said.

Ms. Smith, her common-in-law husband Larry Milley and Mr. Nakeff were remembering the events of that day last Thursday at the Brampton home of a friend where the homeless couple are staying until they can rebuild their lives. Everything in the house was destroyed by the fire and since the couple were just working on insuring their belongings for theft, they've been left virtually penniless with only the clothes on their back.

Realizing their plight, Mr. Nakeff took his story to the Acton Lions Club, of which he is a member, and was able to donate \$200 to the couple on behalf of the club Thursday.

Mr. Milley said the support from Mr. Nakeff and people like him has been tremendous. "I can't begin to thank everybody for all they've done for us."

· The couple's only great sorrow is that their two pet dogs were killed in the fire. The neighbors tried to save the dogs but there was no way they could be saved, said Mr. Nakeff. The dogs were in the basement where the Brampton fire department said the fire started after a chair was pushed too close to an electrical backboard heater.

Both dogs died of smoke inhalation and were cremated by the Brampton Humane Society.

"I wished we could have done more for the dogs but we couldn't," said Mr. Nakeff. "I'm thankful we could save her."

Despite the personal loss of their pets and belongings (fire damage was estimated at \$100,000) the couple are optimistic about their future and grateful to Mr. Nakeff who is now a 'hero' in their eyes.






