Sarnia's 403 Wing will host the 42nd Annual Ontario Group Convention of the Royal Canadian Air Force Association May 17 to 19. 5. Only one composter will be provided per dwelling.
6. Residents who purchased a composter from the Town in 1990 are not eligible for another.
7. Purchasers agree to participate in follow-up studies which will be conducted to evaluate the success of the program.
