## New converts attend Reform Party Open House

The Reform Party's stand on fiscal management and immigration are two reasons the turnout was excellent last Wednesday at the Party's Halton-Peel Riding Association first-ever public information meeting at the Cedar Springs Motel in Halton Hills, says one of the association's directors and Georgetown resident Rod Pinkney.

Mr. Pinkney said following the meeting over 100 people attended the public information session and those in attendance said the party's biggest appeal is its support for huge cutbacks to the

number of federal government civil servants and stand for tougher immigration legislation.

Once in power, the party would make drastic reductions in federal government middle and senior management civil servant positions, said Mr. Pinkney.

On the issue of immigration, Mr. Pinkney said, Canada's current immigration laws make it too easy for people to claim refugee status.

"I don't buy that just because a boat load of people spend money to get to Canada that they should automatically be granted refugee status," said Mr. Pinkney.

He also commented the party would attempt to improve the work ethic among Canadians. Too many people are looking for handouts these days, he said. The party favors a return to the work ethic that was prevalent during the 30's when he was a kid, explained Mr. Pinkney.

Mr. Pinkney went on to say people attending the information meeting, like the party, question the need for the federal government to fund multicultural and bilingual programs.

The party believes it's great that people retain aspects of their culture and language when they emigrate to Canada, but they shouldn't expect the Federal Government to provide financial support to achieve this goal, he said.

Mr. Pinkney said the association will have a candidate to run against current Halton-Peel MP Garth Turner in the next federal election. However, he wouldn't venture to predict how the candidate would fare.

Contacted last Thursday, Mr. Turner said the Reform Party will only have a chance both locally and across Canada if between now and the next election, Canada breaks up.

The only negative reaction to the party expressed during the information meeting was the fact the party has had little exposure in Quebec, said Mr. Pinkney.

"Quite a number of people at the meeting thought we shouldn't ignore Quebec because there are a lot of anglophones in that province," he said.

The party will be unsuccessful at developing a national base, "if it looks like the party is picking a fight with Quebec," he added.

### Making space in your kitchen


containers that take up a lot of room. These fit into the comers of your bottom cabinets where you would normally have to really reach at things.
