Hydro Commissioner all wired-up for election

Life-time Acton resident Roger Haggett, 39, is the first Halton Hills Hydro Commisioner to declare his candidacy for the upcoming Nov. 12 municipal election.

The four current commissioners include Murt Allison, Bill Smith, Jim Fisher and Town Mayor Russ Miller. The Halton Hills Mayor is appointed to the commission automatically.

Vying for a commissioner position in Acton's Ward 1, Mr. Haggett says if elected he would be prepared to take on the position of Commission Chairperson. This position is rotated between commissioners once a year. For 1992 the chairperson position will be held by the Ward 1 representalive.

"I feel the position requires someone with the dedication and experience to see the commission through what will certainly be very trying times with Ontario Hydro's announced 10 per cent increase to its 1992 electricity

rates. The commission buys power from Ontario Hydro.

Mr. Haggett predicts the total increase to Halton Hills residents 1992 hydro bills will total 15 per cent when the commission accounts for increases to its expenses other than electricity.

Mr. Haggett, who is married and a father of three teenage daughters, says the role of the commission chairperson is "to steer the commission in a way that is beneficial to local taxpayers."

He believes the commission should lobby Ontario Hydro to reduce its price for electricity, as well as continue commission efforts to promote energy conservation in Town.

The commission came under public scrutiny last year when the Herald revealed the five commissioners spent approximately the same amount on conventions in 1989 as 55 elected municipal politicians and school trustees in Halton Region did during the

same year.

Joining the commission halfway through 1989, Mr. Hag-

gett attended one conference that year, spending \$765 of Commission funds. Comparatively, his counterpart Murt Allison spent almost \$14,000 of Commission funds over 12 months in 1989.

The commissioners spent a total of just over \$33,000 to attend conventions and conferences during 1989. Mr. Allison was the big spender followed by Bill Smith who spent \$7,014; Russ Miller, who spent \$6,144; Jim Fisher who spent \$3,600 and Mr. Haggett.

Mr. Haggett said he acted responsibly at the time and continues to do so. At the end of July, 1991, Mr. Haggett had spent \$1,204 to attend two conferences. As a commissioner he receives a monthly stipend of \$251.15, according to commission records.

Following the Herald's expose on the commissioner's 1989 spending habits, the utility's convention policy was changed disallowing commissioners to take their wives to conventions at the expense of the commission.

Mr. Haggett said he favored that policy when he arrived on the commission and he supports it now.

The public shouldn't be required to cover expenses of any elected official's spouse incurred as a result of attending a convention or conference, he said.

Asked if a cap should be imposed on commissioners concerning how much they can spend on conventions per year, Mr. Haggett replied no. "Each commissioner should be responsible for himself," he said.

Ironically, when interviewed in 1989 Mr. Haggett said he favored a ceiling being applied to the number of conferences each commissioner could attend yearly.

The other four commissioners have spent the following amounts to attend conferences during the past seven months: Murt Allison \$2,793, Jim Fisher \$2,544.32, Bill Smith \$2,010.10 and Russ Miller \$2,960.

Disabled services approved

A recommendation to complete a strategic plan for services for people with physical disabilities in Halton Region was passed by Halton Regional Council

Approval was given to apply for funding (100 per cent) from the Provincial Ministry of Community and Social Services (MCSS). Community Health and Support Services Division, to undertake a joint study with the Halton District Health Council (HDHC).

In April 1991, Zanana Akande, Provincial Minister of Community and Social Services, announced Halton District Health Council and Halton Regional Council would receive \$50,000 to develop a strategic plan for persons with

Area food banks need support

The economy may be on the upswing but local food banks are serving more people than ever.

Laura Ellison, Executive Director for Georgetown's food bank Love and Christ, says more than 600 people or approximately 300 families are currently using the food bank at least once a month, with an average of five new people applying weekly to use the food bank.

- The number of people relying on the Georgetown food bank has doubled over the last year, and Ms. Ellison attributes the increase to the recession and its continued impact.

Most of the people using the foodbank during the last 12 months, said Ms. Ellison, are those who have been laid off because of slow economic times.

"They are not the poor who are used to being poor - those who come from a history of poverty," she said.

"I'm glad the experts are saying the economy is turning around but we don't see it," she sald.

Director Joan Waldie also said the supposed ending of the recession hasn't been reflected in a significant decrease in the number of people using her food-

Approximately 80 families, it is estimated, will have used the foodbank by the end of the month which is slightly less than the average number of 120 families that normally use the foodbank, said Ms. Waldie.

Ms. Waldie explains the current number using the foodbank is lower than normal because it's the summer and not as many people are in town. However, she expects the number to equal or surpass the 120 figure starting in September.

Both Ms. Waldie and Ms. Ellison agree the majority of people now using their food banks are people in desparation.

"We had 10 people today (Aug. 20) and these people had no hope, they were desperate," said Ms. Waldie.

Ms. Ellison said most of the people using the foodbank these days have run out of unemployment insurance and are now on welfare. "They are finding the welfare benefits don't cover the bills they incurred when they were working," she explained.

Compounding the problem, said Ms. Ellison, is the lack of donations Love and Christ Foodbank is receiving, said Ms. Ellison.

The lack of donations shows a lot of people are still feeling the effects of the recession. "People have to get their house in order before they can think about donating food," she said.

Ms. Waldie said she has sufficient donations to meet the current demand, but her fear is that a lot of people using the foodbank may never stop relying on it even when full economic recovery happens.

A lot of people using Acton Foodshare don't have the training to qualify for the type of jobs that are now becoming available, and if they don't get it chances for a job will always be minimal, explained Ms. Waldie.

Ms. Waldie and Ms. Ellison agree the number of people using their foodbanks will decrease as the economy improves, but Ms. Ellison predicts she won't see any significant decrease for another six months at least.
