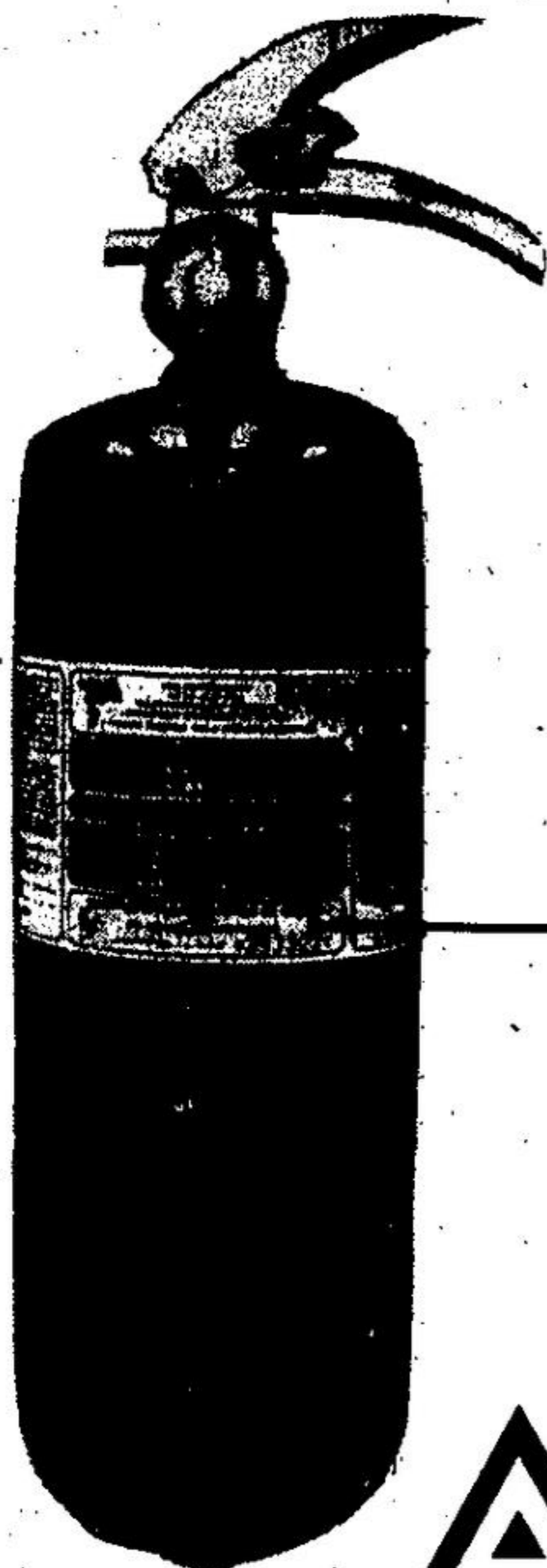


PORTABLE FIRE EXTINGUISHERS

DO YOU KNOW WHAT YOU ARE BUYING?



Portable Fire Extinguishers required to be installed by the Ontario Fire Code are required to be listed by ULC (Underwriters' Laboratories of Canada).

The Halton Hills Fire Department strongly recommends that only ULC listed portable fire extinguishers be purchased for any application.

The ULC listing is your assurance that the extinguisher meets a specified standard of performance.

DRY CHEMICAL FIRE EXTINGUISHER

CLASSIFICATION 2A, 10-B, C



The letter 'A' on the classification means the portable fire extinguisher has been tested and meets the Standard for use on ordinary combustible fires such as wood, paper, cloth, rubber, etc.



The letter 'B' on the classification means the portable fire extinguisher has been tested and meets the Standard for use on flammable liquid and gas fires such as gasoline, cooking oil, propane, etc.



The letter 'C' on the classification means the portable fire extinguisher has been tested and meets the Standard for use on fires that are energized with electricity.
