**Pedestrian struck**

Four Halton Hills residents were taken to Georgetown and District Hospital with minor injuries after a Georgetown woman lost control of her vehicle and struck a pedestrian Dec. 3. The woman, along with two female passengers, was travelling on Queen St. in Georgetown in a 1986 Chevrolet Caprice when she lost control and her car mounted the curb. The vehicle struck a Georgetown man, a hydro pole, a tree, and then a parked vehicle. The Caprice was demolished and the other vehicle sustained minor damage.

**Hazardous ice**

A Halton Hills woman, travelling on an icy, snow covered 6th Line in Halton Hills Dec. 4, lost control of her vehicle and slid into a ditch where her 1987 Toyota rolled over. The vehicle was demolished but the woman was not injured.

**Two injured**

Two Halton Hills men were taken to Georgetown and District Memorial Hospital with minor injuries Dec. 3 after a two car collision. The driver of a 1989 Ford Arrow van was travelling on Confederation Rd. in Georgetown while he was attempting to make a turn, he rammed into a 1988 Pontiac Grand Am. Severe damage was caused to both vehicles.

**Break and enter**

Numerous valuables including jewellery, a leather jacket, and a word processor were taken Dec. 2 during the break and enter of a Georgetown home. Entry to the house was gained using a bar to pry open two locked doors leading into the house, police say.

**Common law assault**

Police report an Acton woman was assaulted by her common law husband in their Acton home Dec. 1. The couple entered into an argument over alleged drug use. The man struck her on the right side of her head. The man then struck the woman's father who had interrupted the argument and then left the scene. Halton Regional Police later found the suspect in Acton and arrested him on two counts of assault.

**Slashed tires**

According to Halton Regional Police, a Rockwood man had his tires slashed while at a Georgetown bar Dec. 4. Police report an Acton man had been trying to pick a fight with the Rockwood man because the complainant's brother was living with the suspect's ex-girlfriend. The suspect began picking on the complainant at a local bar. The owner had the suspect leave after which time the suspect punctured the tires on the left side on the complainant's vehicle. The investigation continues.

**Unexpected visit**

Halton Regional Police report a Halton Hills family received unexpected visitors Sunday when an out-of-control car slid onto the rear deck of their house. The incident occurred when an Acton man, driving a 1987 Ford pick-up entered a curve on Mill St and lost control of his vehicle, running it off the road and striking a sign pole before running over a hedge, wood planter, then

rolling onto the road and sliding into the deck. The pick-up was demolished and the driver sustained minor injuries. He was charged with impaired driving and driving without a valid licence. He will appear in Milton court Jan. 20.

**Flying headlight**

A two-car collision on Mill St in Georgetown Dec. 1 resulted in another car being hit by a flying headlight, report police. The accident occurred when a Niagara Falls man, driving a 1986 Pontiac sedan, was pulling away from the curb into the path of an 1988 Dodge sedan, driven by an Acton man. The Dodge struck the Pontiac which spun around and lost a headlight which went flying into the air and struck another oncoming vehicle. The Pontiac was severely damaged, the Dodge moderately damaged and the third car lightly damaged. The Niagara Falls man was charged with making an improper turn.

**Breaking rails**

Police charged a Guelph man with failing to stop after he collided with a 1982 Chevrolet driven by a Georgetown woman at 10th Line north of 22 Sideroad. The woman was westbound on 22 Sideroad travelling through the intersection when the Guelph man, driving a 1990 Ford proceeded into the intersection and they collided. The collision forced the Georgetown woman into a slide and she ended up breaking through three guard rails and came to rest down an embankment. She suffered minimal injuries but her car was demolished. His car only received minor damages.

**Pedestrian hit**

Police say a pedestrian walking along Queen St. north of McNabb St. in Georgetown was hit by a car out of control Dec. 3. Police say the incident occurred when a Georgetown woman, driving a 1986 Chevrolet sedan lost control of her car, mounted the curb and struck the pedestrian. The woman then struck a hydro pole, spun around and hit a 1983 Chevrolet Camaro, driver unknown. Four people in the Chev sedan were injured ranging from minimal to major injuries. No charges were laid.

**Tools stolen**

Tools and a television were stolen from a gravel pit shed on the 5th Line in Halton Hills overnight Dec. 5 police report. The culprits smashed a window and reached in to unlock the door to gain entry. The place wasn't ransacked but the above mentioned items were stolen.

**Lost identity**

A Georgetown man's driver's license, cheque book, wallet and credit cards were stolen from his Webster Way home Friday night say police. Police say an unknown person used a prying bar to open two doors to the house and then went directly to a coat hung over a chair in the living room and removed the wallet. Police believe the suspect was then frightened off by the complainant and his wife returning home. They saw him flee in a new model Bronco-type truck that was either black or dark blue. Police are continuing their investigation.

**Male sought in assault case**

The Halton Regional Police in Milton and Crime Stoppers of Halton are asking for the community's assistance in identifying the man responsible for an assault upon two children ages 10 and 11 years.

On Thursday the 14th of November, 3 young boys were playing hide and seek, in the townhouse complex, situated at 741 Woodward Ave., Milton. At approx. 8:15 pm, a brown, 4 door car, believed to be a 1983-1986 Chevrolet, Malibu with several square taillights drove into the complex. There was a man in late 40's to early 50's driving the car and a female passenger. The driver questioned one of the boys as to what they were doing and then drove around the complex twice and left.

A short time later this same man came back on foot and approached the boys. He yelled at them to come over to him and then chased one of the boys. He caught one young fellow and grabbed him by the throat and threw him up against the building. He then carried the first victim over to where the second victim was standing and he grabbed the second boy by the throat and told him he was going to hurt them both much worse if he ever sees them again. The suspect released both boys and they ran home and reported the incident to

police.

The suspect is described as a male white 45-50 years of age, medium build, with short whitish/grey hair, wearing large glasses and a brown jacket (possibly suede) and black pants.

The assault upon these two young boys was totally unprovoked. The suspect's vehicle was last seen in the immediate area of

Briar Cres. in Milton.
