Taking a walk down Main Street in Georgetown over the weekend we were saddened to see seven empty store fronts.

The recent closing of Boughton Jewellers and the announcement that Bi-Way may be re-locating makes you wonder what will happen to downtown Georgetown.

We had candidates running for council state when elected they were going to revitalize the downtown. We have the BIA (Business Improvement Area) stating it will do everything in it's power to stop Bi-Way from moving out of the downtown core. We have had citizens say we should put in a Farmer's Market. We have had developers present plans for the redevelopment of the downtown, which include low rise condominiums and high rise apartments, only to be discouraged.

But, to date nothing has happened.

If nothing else, the developers' plans would allow the downtown core to survive.

Recently it was mentioned to us that possibly a seniors centre and art gallery could together be in the downtown. Why not use the old town building?

This move away from the downtown is not something new. This once vibrant downtown, housed the local movie theatre, liquor store and beer store, is now losing it's identity. Even the town financial office moved off Main Street two years ago and still remains vacant.

There appears to be an endless stream of unanswered questions.

Why hasn't someone done something to stop this decay?

Why can't Georgetown turn it's downtown street into another Unionville or St. Jacob? Why can't downtown which has been used for movie sets be turned into a quaint area to attract tourists?

Why couldn't the town make architecture a condition for development? Why hasn't the BIA gone to the town and asked for assistance in saving the downtown's heritage?

What can be done?

Well first, let's stop asking questions and trying to blame others for the problems in the downtown core. The BIA should take a long hard look at the future of the downtown and put together a plan to rejuvinate it. The BIA will not accomplish this task over night, or by themselves. They will need the assistance of town staff, developers and concerned citizens.

Today it's not to late. But, if we wait until tomorrow it may never come.

Re: Christmas Fire Safety Regarding the Georgetown




