Entitlements are well-deserved

Outline of the Pension Act Entitlement:A pension may be awarded for death, disability, or aggravation of a pre-enlistment condition.

Disability: The loss of, or lessening of, the power to will and to do any normal mental or physical act.

The entitlement may be awarded if incurred or attributable to military service in: World War I or II, Korea, a Special Duty area, eg: Egypt, Indo-China, Cyprus, the Persian Gulf etc., during specific periods. Directly connected to or aggravated by service in the peacetime Regular or Militia (Reserve). Additional disability as a consequence of the primary condition in any of the above issues.

Obvious on enlistment: apparent to an unskilled observer.

Recordedon medical prior to enlistment.

Presumption: neither obvious or recorded. Arising out of or directly connected to military (peacetime) service.

Fractional entitlement: on the basis only part of the disability was due to military service.

Pension for Spouse: any additional payable is proportionate to the pensioners award.

Common Law: opposite sex, if lived with not less than one year, may be deamed a spouse, and following death may be deamed survivor.

Pensions for surviving spouses: eligibility, must have been attributable or incurred during service. (Peacetime service, death must be proven to have arose out of or directly connected with such service).

Treatment: a disability pensioner is entitled to medical treatment for a pensionable disability.

Note: there are many other clauses re: pensions and information is available upon request.

Veterans Independence Program Assistance to eligible veterans to help maintain and improve the quality of life, (Independence in the community of their home). Some of the services available include, counselling, health information, abulatory health care, home care, transportaion adult residential care, nursing home intermediate care, groundskeeping and housekeeping, also veterans qualify for full treatment benefits.

Special benefits: Execptional Incapacity Allowance 100 per cent pensioners.

Attendance Allowance: any disability pensioner who is totally disabled and in need is eligible,

this does not have to be related to the pensionable condition.

Clothing Allowance: pensioners, who may wear certain appliances or exceptional soiling problems, amputations, etc may apply. Note: Paired organ claim, eg: additional limb may entitle a pensioner to an increase of 12 original pension.

P.O.W. Compensation: This act was passed in 1976, for all prisoners of World War II, and was amended in 1978, extending compensation to prisoners of World War I, and also escapers and evaders. The awards are subject to special conditions. Information is available upon request.

Gallantry Award: certain awards get an additional \$50. a year.

Last sickness and Burial expenses: The Commision may pay if a need exists.

War Veterans Allowance: Veterans who served in a theatre of war, eg: WWI, WWII, or both, or left Canada or U.S.A. including Alaska as a member of the Canadian forces, or as a member of a Canadian force to serve in the U.N. Korea, prior to 27 July 1953, can apply. Note: this includes service beyond the three mile territorial limit.

Civilian War Pensions and Allowances: may be awarded for death, disability or aggravation of a pre-enlistment condition. The list of civilian services is extensive, but information is available upon request.

Veterans of Commonwealth or Allied Forces, are eligible, if living in Canada at time of joining, or have lived in Canada for at least 10 years.

Supplementary Pension: Commonwealth and Allied Forces. Conditions for awards under this section of the act are available upon request.

Pensions for Imperials all matters pertaining to British pension claims are considered at the Department of Social Security, Office Norcross, Central Blackpool, England. Provincial Command Service Officers can provide assistance in claim preparation. Polish Veterans who served during World War II under British command are in the main the same as British pension applicants.

Last Post Fund: Canadian exservicemen and women, whether they die in Canada or abroad, are eligible for burial assistance if specified service and financial qualifications exist at the time of death. This includes civilians on active service, or those in receipt of C.W. Pensions or Allowances. Ex-servicemen and women who served in Allied Armed Forces, are also eligible if they die in Canada. Applications may be made through Provincial representatives, Service Officers, or to the head office of the Last Post Fund.
