### MANAGER OF DESIGN AND CONSTRUCTION Posting No. 201013

Reporting to the Director of Infrastructure Services and Town Engineer, this position is responsible and accountable for the management of the Design and Construction section of the Infrastructure Department, including reconstruction of roadways and structures.

#### Responsibilities:

- Provide effective management and supervision of the Design and Construction section.
- Monitor capital budget and operating budget expenditures.
- Coordinate preparation of the department's yearly Capital Budget and nine year forecast.
- Oversight of the Town's Infrastructure Management System including assessment and reporting of the cumulative engineering infrastructure deficit.
- Negotiate subsidy arrangements for capital reconstruction Connecting Link projects with the Ministry of Transportation Ontario.
- Author Reports to Council on construction related projects, and attend Council meetings as required.
- Retain and coordinate legal surveyors and geotechnical consultants in respect to departmental requirements.
- Hire, monitor and evaluate consultants carrying out engineering projects on behalf of the Town.
- Provide contract administrations and co-ordinate Halton Region staff on joint construction projects.
- Review, sign and provide Professional Engineer's stamp to engineering drawings prior to tendering.
- Review department engineering designs and quantity calculations for tender preparation.
- Attend Public Information Centres respecting Design and Construction Works.

# Halton Place meets criteria for horse shows to be held

Halton Place, the 15 Sideroad horse farm, has fulfilled all outstanding issues related to a Town site plan agreement before time ran out.

This allows the farm's planned equestrian events for this spring and summer to go ahead as scheduled, as approved under a Niagara Escarpment Commission (NEC) development permit issued last year.

In March, council directed that Halton Place must have all outstanding Town site plan matters, related to pavement and stormwater management, resolved at least 30 days before the first event of the 2010 season—May 26.

The Town signed off on the site plan on April 23.

Halton Place received approval of the required pavement and stormwater studies, completed site plan amendments as a result of these studies' recommendations, and secured and certified the completion of the site works.

In future years, Halton Place will not be required to get a new site plan, as long as the scale of the event-related facilities and infrastructure remains unchanged.

Unlike previous council reports dealing with Halton Place there were no residents opposing Halton Place's actions or solicitors speaking on behalf of the farm. This report, an add-on to the agenda, was dealt with without comment by council members. However, Regional Councillor Clark Somerville asked if people were notified about its inclusion on the agenda. Staff replied Halton Place's owner and legal counsel, residents who live on neighbouring properties, the NEC and Conservation Halton were all contacted about the report's inclusion.

Meanwhile the NEC is dealing with a controversial—between Halton Place and opposing neighbours—noise attenuation berm as a separate issue from Halton Place's development permit for the 2009-10 events.

## Ward 2 incumbents to run

Ward 2 incumbents Bryan Lewis and Joan Robson filed their nomination papers Thursday to seek re-election to Halton Hills Council on Monday, Oct. 25.

Both Robson and Lewis were first elected to council in 2000, were both acclaimed in 2003, and survived one challenger in 2006.

Since January, seven of the 11 members of the current council have filed papers for re-election: Mayor Rick Bonnette, Lewis, Robson, Wards 1 & 2 Regional Councillor Clark Somer-

ville, Ward 3 Councillor Dave Kentner, and Ward 4 Councillors Bob Inglis and John Duncan.

Halton Hills Catholic school trustee Rosanna Palmieri and Halton Hills public school trustee Gerry Ockenden are also seeking re-election as is Halton Region Chair Gary Carr.

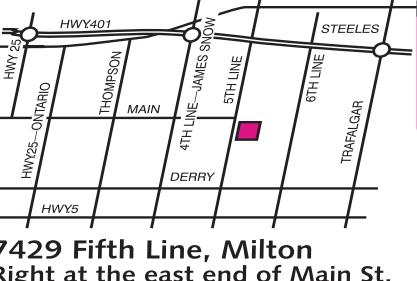
