Class Environmental Assessment Study

Lindsay Court Well Field Expansion

Background

Halton Region initiated a Class Environmental Assessment (EA) Study in November, 2007 for the provision of additional water supply capacity from Lindsay Court Well Field to the Georgetown urban area and Halton Hills hamlets of Stewarttown, Glen Williams and Norval (see map of study area). The project was identified in the Georgetown Water Supply Master Plan Review (June 2003) to provide additional municipal water supply for future growth in the Georgetown urban area.

Problem Statement

To supply additional municipal water to the Georgetown Urban Area by evaluating an increase in the daily water taking at the Lindsay Court Well Field from 6,545 m³/day to 7,500 m³/day.

The Process

The study is being conducted in accordance with the requirements of a Schedule 'B' project under the Municipal Class Environmental Assessment (October 2000, as amended in 2007), which is an approved process under the Ontario Environmental Assessment Act. The Class EA process will include public and review agency consultation, an evaluation of alternatives, an assessment of the potential environmental effects of the proposed improvements, and identification of reasonable measures to mitigate any adverse impacts that may result.

Public Information Centre

A Public Information Centre (PIC) has been planned to obtain input on the work completed to date, including a list of alternatives and the proposed process to evaluate the alternatives. The PIC is scheduled for:

Representatives from Halton Region and its consulting team will be present to answer questions and discuss the findings and next steps for the study. You are encouraged to attend the PIC and provide your comments so that they may be included in the study. Comments and information regarding this study are being collected in accordance with the Freedom of Information and Protection of Privacy Act and to assist the project team in meeting the requirements of the Class EA process. With the exception of personal information, all comments will become part of the public record.

At the study's conclusion, a Project File Report will be prepared to document the planning process followed and will be available for a 30-day public review period. Notification of the review period and locations where the public will have access to the report will be made by means of a similar newspaper notice and a letter mailed to those on the project contact list.




This year's rain barrels have a new look and price at only \$36 each (cash only).

Ontario Street Affordable Housing Project



Recently, I was proud to gather with representatives from the Governments of Canada and Ontario, Halton Region, and the Town of Milton to announce funding for the development of a new affordable seniors housing project in Milton.

The 80-unit housing project received \$4.8 million under the Canada-Ontario Affordable Housing Program for 32 units for people living on low incomes and eight units for persons with disabilities. Halton Region is contributing \$10,160,000. Council, together with Regional staff, Local Municipalities and the Ministers at the provincial and federal governments, have been working very hard to get this funding approved. It is so important that people at all stages of life can remain in their community.
