A Mississauga man is facing charges after Halton Police executed a search warrant at a rural property on Ninth Line last Tuesday afternoon.

Officers recovered two stolen 35-foot tractor-trailer loads full of new tires. In total there were more than 760 tires valued at \$129,000.

Police say one load of tires had been

stolen from a truck stop on Hwy. 401 near Cambridge and the other load sometime while enroute from Ontario to Beaumont, Quebec.

Police do not know when the tires were stolen.
