Much like the Bulldogs, the Saints relied on a scoring-by-committee approach, with eight players reaching double figures in goals.

With high scorers such as Pat Saunders and 50-goal man Dylan Webster having moved on from last year's squad, the Bulldogs have had to change their approach and McCauley is happy with

how his younger players have challenged the veterans for prime playing time in clutch moments.

"We're not as skilled as we were but I think we're more well-rounded in a lot of areas— defence, grit and transition," he added.

Milton's Ethan O'Connor, who is also playing full-time with the Burlington Jr. A Chiefs, has been a key player at both ends of the floor for Halton Hills, with experienced players such as Justin Reid, Kody Lyons, captain Nik Matwijszyn and Clark De Geer providing stability as well.

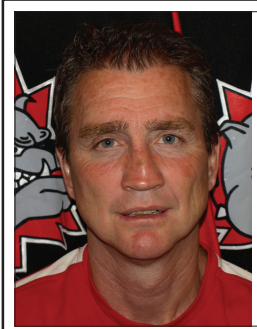
