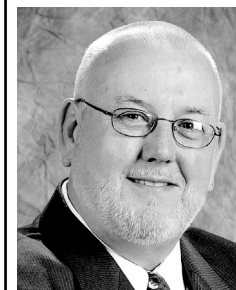


**GILLIAN
