


NOTICE OF SUBMISSION OF TRANSPORTATION ENVIRONMENTAL STUDY REPORT

Ministry of Transportation, Ontario (MTO)
 Highway 7 Rockwood (GWP 155-91-00)
 Detailed Design and Class Environmental Assessment

BACKGROUND

The **Ministry of Transportation (MTO)** retained Dillon Consulting Limited to complete the Detailed Design and Class Environmental Assessment (EA) process for the rehabilitation of 4.1km of Highway 7 from 0.07km west of Fall Street to 0.5km east of Halton Regional Road 32 (to Eden Mills) in the community of Rockwood, Township of Guelph-Eramosa and Town of Milton. As part of the project, the Ministry is proposing to:

- rehabilitate the roadway to address existing pavement conditions (the highway will remain open throughout construction)
- rehabilitate the Eramosa River Bridge, with one lane of traffic maintained on the bridge during construction
- provide continuous sidewalk (new or existing) from Fall Street to Dunbar Street/MacLellan on both sides of Highway 7
- replace existing curb and gutter and paved shoulders where impacted by construction throughout the project
- rehabilitate the existing storm sewer system, as required
- replace/rehabilitate existing culverts, as required (the Richardson's Creek Twin Culverts will be rehabilitated by lining the existing culverts and installing an additional culvert — the highway will remain open during construction)
- modify commercial and private entrances as required (directly impacted property owners have been contacted by MTO).



A pre-construction open house will be held prior to construction to provide residents with an opportunity to view the plans. A separate notice will be published in advance of the session.

THE PROCESS

The Transportation Environmental Study Report (TESR) is being made available for a 30-day review period in accordance with the requirements of the *Environmental Assessment Act* and the *Class Environmental Assessment for Provincial Transportation Facilities* (2000). The TESR documents the environmental assessment process completed, including public and agency consultation, key design decisions, potential environmental impacts and mitigation measures included in the Contract. The TESR is available for review during normal business hours from **January 28 to March 1, 2011**, at the following locations:

If concerns regarding the project cannot be resolved through discussions with the Ministry, you may make a request to the Minister of the Environment for a Part II Order under the *Environmental Assessment Act*, to elevate the project status to an individual environmental assessment. Requests must be received by the Minister of the Environment at Ferguson Block, 11th Floor, 77 Wellesley Street West, Toronto, ON M7A 2T5 by March 1, 2011. A copy of the request must be sent to the Ministry of Transportation at the address below. If no requests are received by **March 1, 2011**, the Ministry intends to proceed with construction as outlined in the TESR.

Information collected will be used in accordance with the *Freedom of Information and Protection of Privacy Act* and the *Access to Information Act*. With the exception of personal information, all comments will become part of the public record.
