

# Use caution near waterways: CH

More wet weather this week has prompted Conservation Halton (CH) to issue a high water safety bulletin, which will remain in effect until Thursday.

Environment Canada is forecasting approximately 30 to 50mm of rainfall for Halton Region for the next few days. The rain was expected to begin yesterday (Monday) with possible thunderstorm activity.

Scattered rainfall is expected to continue over the next few days until the system clears out later in the week.

This rainfall is expected to result in in-

creased runoff to the creeks and cause water levels in streams to rise above normal conditions to near bankfull conditions in some parts of the watershed. CH also expects these conditions to result in stream banks and slopes becoming slippery and dangerous.

Wide-spread flooding is not anticipated, however, increased runoff contribution in creek systems may result in localized flooding in some low-lying areas.

Residents are urged to use extreme caution around bodies of water and stay well back from stream banks.



**From May 9, 2011 to May 17, 2011**


