Notice of Passing of an Official Plan Amendment OPA 204 and Zoning By-laws BL-2012-093 and BL-2012-094 **Drive-through Service Facilities in the Town**

TAKE NOTICE that the Council for The Corporation of the Town of Caledon on August 14, 2012 passed By-laws No. BL-2012-092 to adopt Official Plan Amendment OPA 204, BL-2012-093 to amend Comprehensive Zoning By-law 2006-50, as amended and BL-2012-094 to amend Comprehensive Zoning By-law 87-250, as amended under Sections 17 and 34 respectively of the *Planning Act*, R.S.O. 1990, c.P.13 to permit and address the design and development of drivethrough service facilities in the Town.

explanation of the purpose and effect of the Official Plan Amendment is provided below. u wish to appeal the decision of the Council, a notice of appeal must be filed with the Clerk of Corporation of the Town of Caledon not later than September 10, 2012. A copy of an appeal is available from the OMB website at www.omb.gov.on.ca or by contacting the Town Clerk.

- set out the reasons for the appeal; be accompanied by the Ontario Municipal Board fee in the amount of \$125.00, which can only be paid by certified cheque or money order made payable to the Minister of Finance, Province of Ontario; and,

The purpose of Official Plan Amendment 204 is to add new policies to the Town of Caledon Official Plan to address issues related to drive-through service facilities. The proposed policies provide directions as to where these facilities may be located and address issues related to their

The basis for the Amendment is contained in staff reports DP-2012-062, DP-2012-005, PD-

In 2004, Caledon Council adopted Official Plan Amendment (OPA) No. 191 which prohibited drive-through service facilities in the Bolton Core Area. Subsequently, in January 2005, Council endorsed the Terms of Reference for the study of drive-through facilities, directing staff to

The proposed Official Plan Amendment (OPA) 204 will strengthen the existing Town of Caledon Official Plan policies regarding drive-through service facilities by identifying locations where these facilities may be permitted, and ensuring that they are compatible with existing and future
