New No Parking policy

Want to stop people from parking in front of your home? You will now need at least three quarters of your neighbours to feel the same way before a request to implement a No Parking zone would be debated by local politicians.

Guelph/Eramosa Township Council's new policy for No Parking designations on residential Township roads, until now done on an ad hoc basis, now requires a petition singed by threequarters of households on the street in question. The Township clerk would send the petition to Council for consideration, and if Council agrees to investigate the request, it would talk with other affected agencies, including police. The Township's Bylaw Enforcement officer would then prepare a report for Council debate.

Matthew Williamson, the Township's Bylaw Enforcement/Property Standards Officer said the policy gives staff direction when a small percentage of people on a street want a No Parking zone, and others don't.

Mayor Chris White said the policy gives the Township a process to determine if a request for a No Parking zone is reasonable, and can be reviewed using traffic data, so Council doesn't react "before getting all the details."

After the meeting, Williamson said requests for No Parking zones on residential streets are "not frequent," but the policy positions everyone after staff does a technical review.

Street names chosen

A former Township employee, two War Dead and a Rockwood area pioneer family will be honoured by having streets in a new Rockwood subdivision named after them.

Guelph/Eramosa Township Council recently approved four names submitted by Nobel Ridge developer Harris Street Development Inc. They include: Sammon Drive and Coker Cres-

cent representing the War Dead, Drenters Court representing an early pioneer family, and Gagnon Place to honour the late Ken Gagnon, the Town's former Manager of Public Works.

The Township's street naming policy requires that half of the names in a new subdivision be named for War Dead, 25 per cent be named after a local pioneer family, and 25 per cent chosen by the developer. Street signs named for War Dead will include a poppy.

On Monday, Council gave Harris Street Developments Inc. approval to build three model condominium units on Jolliffe Street in the Noble ridge subdivision

Charleston Homes spokesman Andrew Mulder said to provide buyers with multi-option choices, two of the units will be model homes and the third will be a décor centre. He also said they plan to begin paving streets in the subdivision within the next four weeks, and the existing model homes will become homes for sale.

Notice of Study Completion BURNSIDE Village of Rockwood Sewage System Upgrades Class Environmental Assessment Study

The Study

The Township of Guelph/Eramosa (Township) has an agreement with the City of Guelph (City) to provide treatment of the wastewater from the Village of Rockwood (Village). The Township, the Ministry of the Environment (MOE) and the City entered into this agreement in 1977, with the MOE transferring their responsibility and obligations associated with the Village's communal water and wastewater systems to the Township. Average daily sewage flows in the Village have steadily increased over the years and are now reaching the agreed upon treatment capacity with the City. The Township has undertaken a Class Environmental Assessment (MCEA) to determine the best alternative to provide sewage treatment to the remainder of the developable lands within the Village

The Process

The study was carried out in accordance with the requirements of a Schedule "B" undertaking as outlined in the Municipal Engineers Association MCEA document (2000, as amended in 2011). A Notice of Study Commencement inviting initial input was first published on October 28, 2010 and a Public Information Centre (PIC) was held August 30, 2012. As the project developed and alternatives were refined, further consultation was completed with the City to determine the feasibility of revising the sewage treatment agreement for the additional treatment capacity for the remaining developable lands within the Village. The preferred alternative includes amending/developing a new agreement with the City for additional sewage capacity and converting the existing the existing siphon system, which conveys wastewater from Rockwood to Guelph, into a pumped system at the Pre-treatment Plant. Controls would be changed, piping/flow modifications would be made, and the addition of operation storage and accommodation for dedicated standby power would be provided. Building modifications and site works will also be required to incorporate the design upgrades. This preferred alternative is a continuation of the Village's current treatment method.

The Project File Report (PFR) has been prepared to document the planning and decision making process undertaken for this study. By this notice, the PFR is being placed on the public record for a 30-day review period (starting September 20, 2012 and ending October 22, 2012) in accordance with the requirements of the MCEA. The PFR is available for viewing at the following locations and has been placed on the



A copy of the request must also be sent to the Township (see below) by this time and date. If no request is received, the Township intends to proceed with detailed design and construction as outlined in the PFR.
