### Willow Park residents get another extension on move

The Credit Valley Conservation Authority (CVCA) has offered to extend its eviction deadline for Norval's Willow Park residents until the summer.

The 17 families in the Norval site. trailer park, after three months of lobbying the CVCA, the Town and the Province for an extension, have been offered until Aug. 31 to find a new home.

The new deadline will not be extended again unless the residents have a "firm relocation proposal, with full tenant support and a final moving deadline," according to the CVCA.

"Unless we see something absolutely solid, and we're guaranteed that they will be gone, then we'll be prepared to look at another extension if they need it," CVCA general manager Vicki Barron said in an interview. "We realized we had to do something, it wasn't fair to just kick them out in the middle of May...We're definitely not looking for bad luck for these people we want them to find a home."

Barron added that a few conditions are attached to the extension. Residents are requested not to pursue further compensation for moving; they must sign an indemnity if damage from flooding occurs, and they must pay the CVCA's legal costs of the extension.

As of press time, the Willow Park residents had not officially accepted the offer. They could not be reached for comment.

It is the second extension given

by the Authority. Residents were originally told to vacate the property on Nov. 15, 1989, but the CVCA extended the deadline until this coming May 15 in order to give them more time to find an alternate

The CVCA expropriated the trailer park over two years ago after designating the area as a floodplain and citing potential threat to property and life.

The residents were expecting to move their homes to Acton's Nor-Halton Park, but the Ontario Municipal Board rejected the plan last December, leaving them with no options.

Halton-North MPP Noel Duignan has since brought the matter to the attention of the Ministry of Housing, which is currently reviewing the matter.

Mayor Russ Miller said in an interview that he is expecting another meeting to be set up with the residents, Duignan and CVCA officials to "find other places for them to

"Duignan said he has some suggestions...but (the Town) will go along with anything they want to do to find these people homes," Miller said. "The ball is really in Duignan's court, now."

When contacted by The Weekend Thursday, Duignan said he expected the Ministry of Housing to have an update on the Willow Park situation Friday (yesterday). The results of the announcement were not available at press time.
