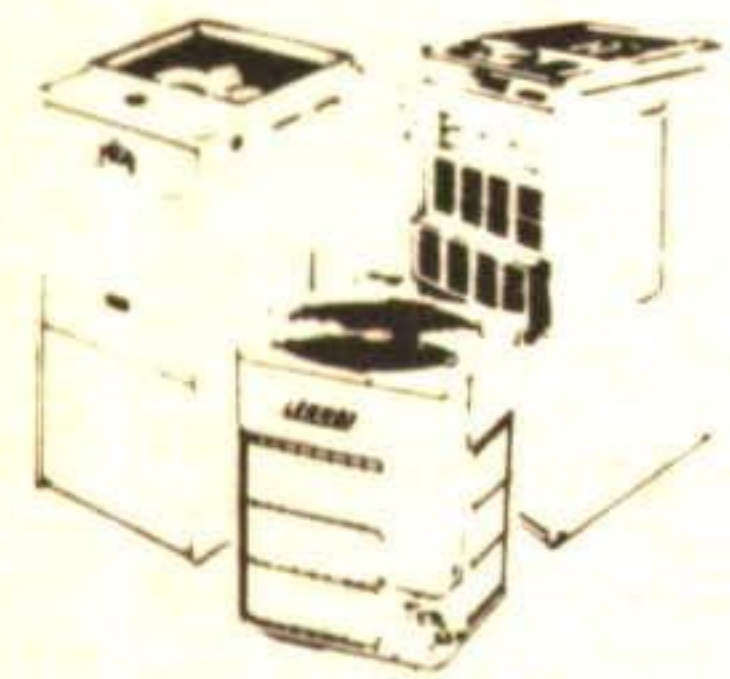

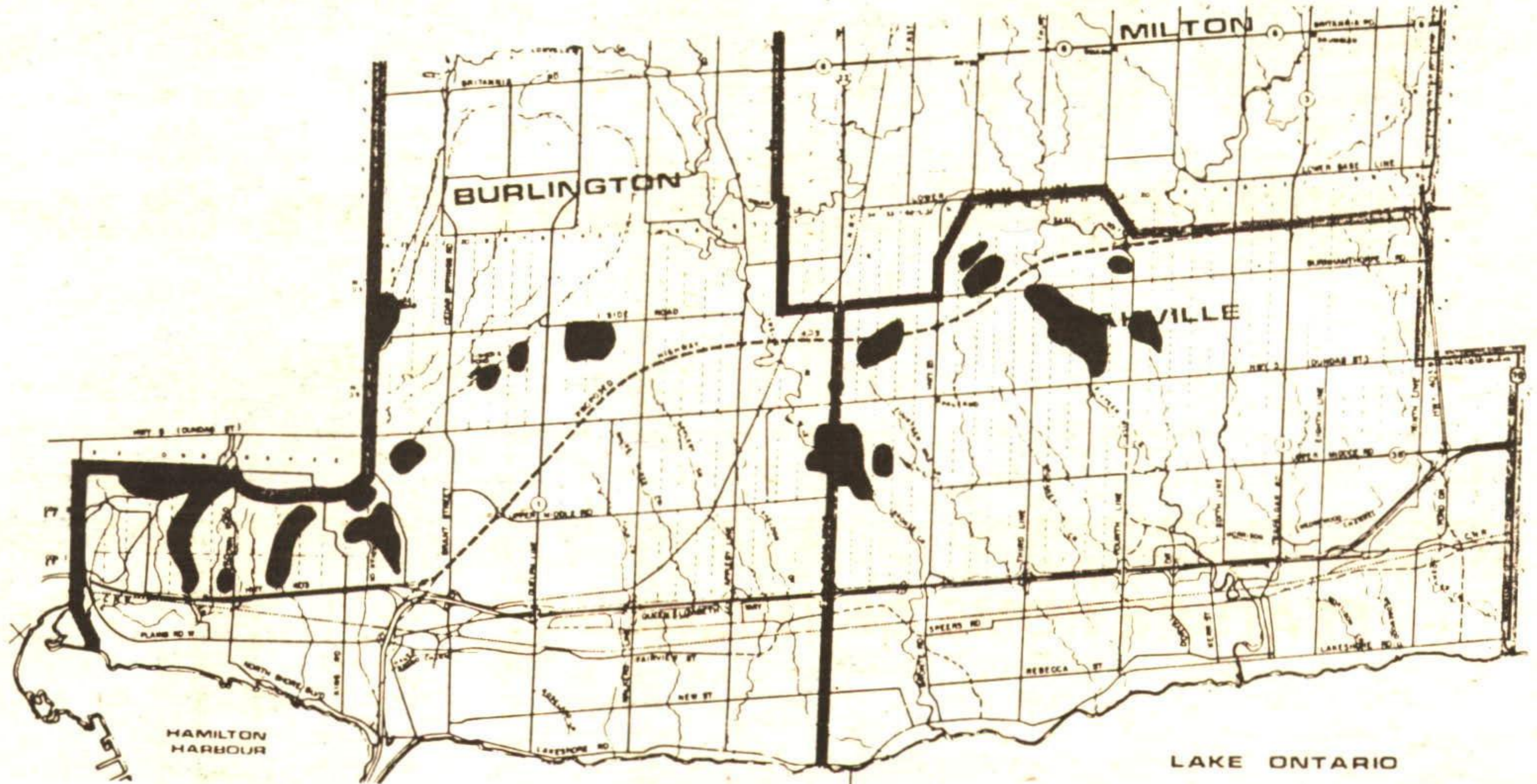
The Region of Halton is proposing to participate in the Ministry of Natural Resources (MNR) Aerial Spraying Program for woodlots infested with Gypsy Moth.

Aerial surveys in 1991 identified about 300 hectares of infested woodlots meeting the MNR criteria for treatment (as shown on map below). The proposed treatment of these woodlots is with the insecticide Bacillus thuringiensis (Bt), which is safe for application in urban and forested environments.

Members of the public who are interested in the program are invited to attend this session. Representatives from the MNR, the Halton Region Conservation Authority and the Halton Public Health Department will be available to answer questions. Presentations will begin at 7:30 p.m.

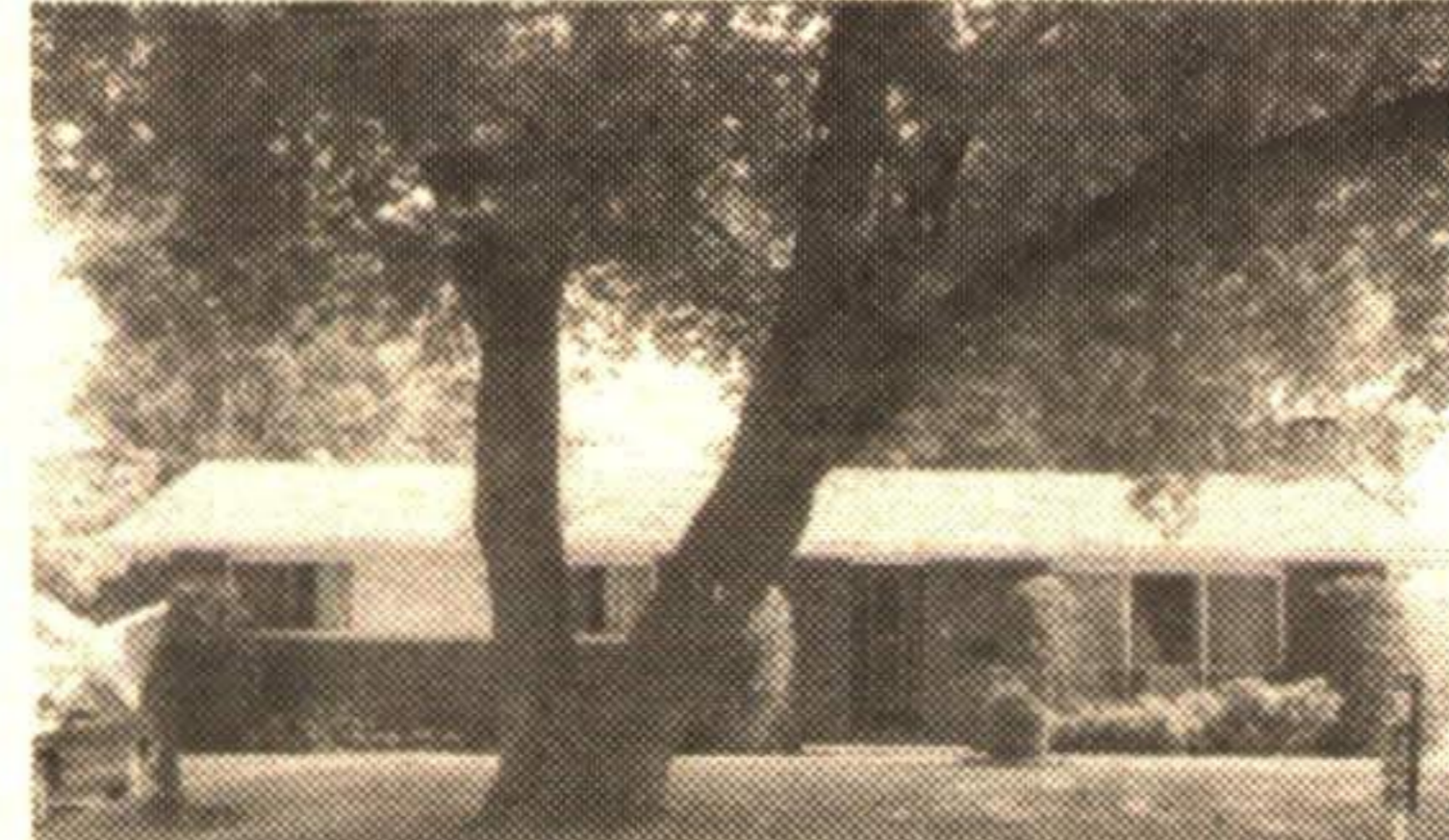

HALTON AGREEMENT FOREST USERS

Regional Council has CONTINUED the ban on hunting and the discharge of firearms within the Coulson Tract Agreement Forest (Part Lot 2, Concession 8 Town of Halton Hills). Described below are the periods when certain hunting and discharge of firearm activities are permitted in all other Halton Agreement Forest, except the Coulson Tract.

Beginning October 15, 1991, through November 3, 1991, and from November 9, 1991, through December 31, 1991, inclusive, ARCHERY HUNTING will be permitted. Archers may be in the Agreement Forests to hunt deer and other small game if in season.

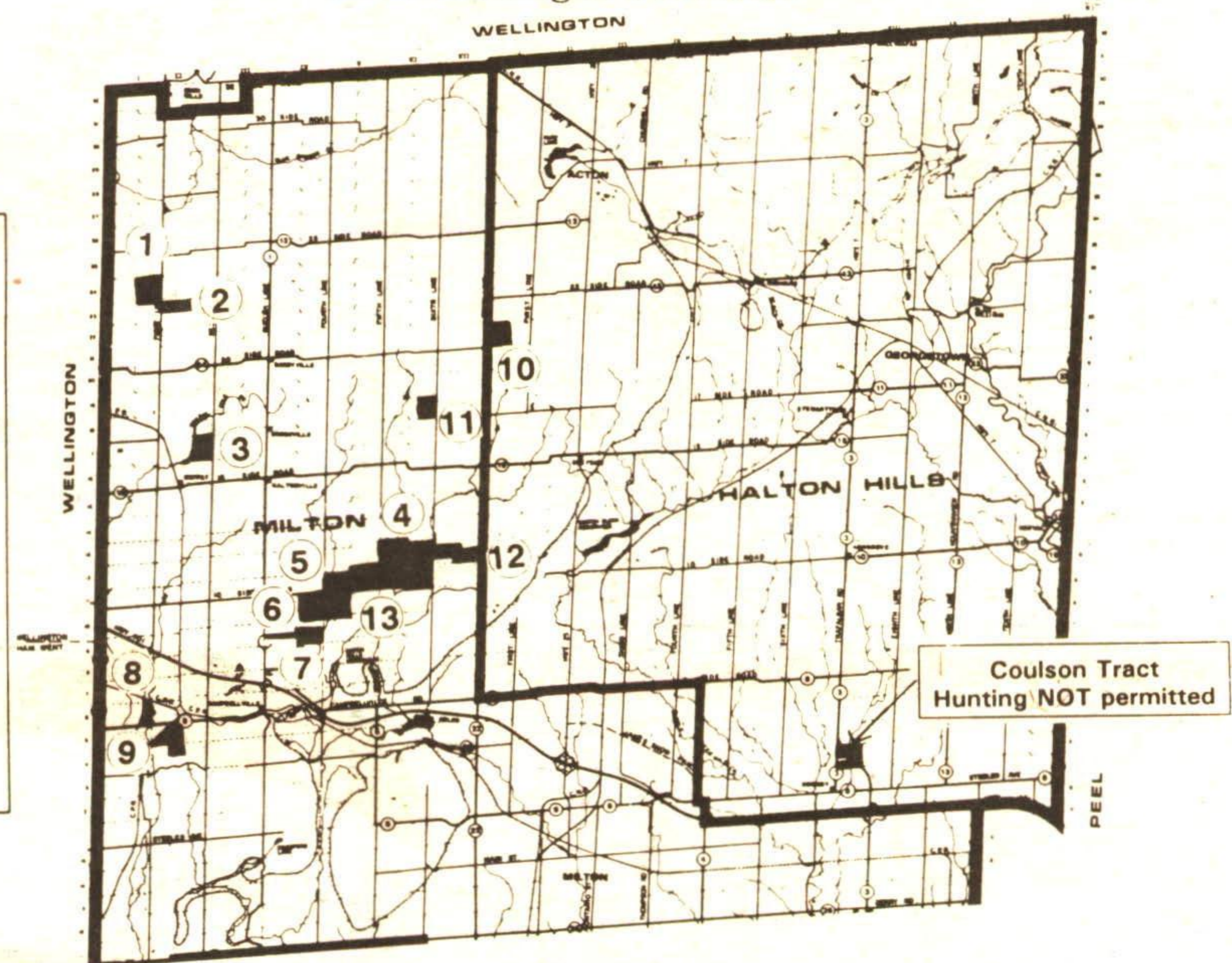
Beginning November 4, 1991, and continuing through November 8, 1991, SHOTGUN HUNTING will be permitted for deer and other small game if in season. On these five days, archery hunting is not permitted in the Agreement Forests.

All users of the Agreement Forests do so at their own risk and are advised to use caution during the times that hunting is permitted.
