Youths sentenced for part in fatal crash

Judgement: 'tap on the hand'

A Milton crown attorney says she may appeal the decision by a youth court judge who ruled jail terms were unnecessary for two teenaged girls responsible for last summer's car accident which claimed the life of 16-year old Carly MacNeil.

Seeking open custody for the young offenders, now aged 18 and 17, Crown Attorney Laurie Jago said she is "considering making a request for an appeal" in the case

which came to an emotional close March 27.

year probation and was ordered to perform 40 hours of community ser-Judge James Fuller said in his vice work. They are both prohibited from driving during their probationary periods.

Carly's mother, Sandy MacNeil, appeared stunned after the sentencing. She later said she, her husband Ron and two remaining children Bobbi and Jamie feel the eldest of the two drivers received only "a tap on the hand" for her actions.

"What about my daughter," Mrs. MacNeil said. "She was an honor student. I've had kids tell me she was a role model."

But Judge Fuller said the girls appeared to be responsible, while noting positive reports submitted from various members of the community concerning their background.

Aged 16 and 17 at the time of the single vehicle accident, the 18-yearold woman was convicted of criminal negligence causing death while the 17-year-old youth was convicted of dangerous driving.

Both of the girls, whose identities are protected under the Young Offenders Act, pleaded guilty.

In January, a 20-year-old Milton man was sentenced to 14 days in jail for buying liquor for the youths who were involved in the fatal crash.

Appeals must be requested within 30 days of the sentencing.
