School fears for safety with loss of adult crossing guard

Council is considering replacing an adult crossing guard on Rexway Dr. at Harrison public school in Georgetown with a Grade 5 student.

A staff report on the traffic situation carried out in May measured the number of children crossing the road during peak hours as well as the number of safe gaps in traffic, of 13 seconds. It found there are an adequate number of safe gaps in traffic and, according to criteria, an adult crossing guard would not be necessary.

"I have spoken to the principal, the parents, to Tom Politi, and all recommend it is not a good spot for a student (guard)," Councillor Ron Chatten said.

But the issue was debated, and the committee decided to send the

report to the school to allow the principal, Max Jackson, and par-ents to comment on it before a decision is made.

A crossing guard costs about \$4,800 annually.

No objections to mobile home


