

Notice of Submission GO Transit has submitted its revised Class Environmental Assessment (Class EA) Document to the Minister of the Environment for approval. Conforming with the 1988 approval of GO Transit's current document, an evaluation of the current Class EA was carried out. The results of the evaluation and the pre-submission consultation undertaken are reflected in the revised document, a draft of which was made available for public review in May 1992.

GO Transit hereby notifies all interested individuals and parties that this project is proceeding through a formal, concurrent government and public review process under Ontario's Environmental Assessment Act.
