Town offers to purchase CN rail land in Acton

The town of Halton Hills has submitted an offer to Canadian National Railway (CN) to purchase a 1.6 acre piece of land in Acton bound by the CN tracks and Eastern Ave, which is currently primarily being used by the Hide House for parking.

Town administrator Ray King said the offer, which was approved in a recommendation Monday night by an eight to five vote, is for about \$50,000. The total expenditure approved was \$91,359. King said the difference will cover the costs of capital improvements that the town will make to the property. Money to pay for the purchase will come buy it. It is an extremely good price from a

from the town's unallocated capital reserve fund.

"Essentially that is a price that we can live with," said King. "There are a number of reasons why it makes sense for the town to purchase it. It could accommodate future road widening and parking in Acton. There has been a demonstrated need for future parking in Acton," said King.

He added the lands could be a valuable asset for the town if GO train service is reintroduced.

"The town has shown an interest in that property for several years, it makes sense to

ported the recommendation. King said the offer to purchase will be considered by the CN board at an upcoming meeting and the town should know sometime in December whether or not CN has accepted

the offer.


House will be able to continue using the property for parking King said "we'll deal with that after the acceptance of the offer."

"We'll likely look at some arrangements but we haven't got into that," said King.

Steve Dawkins, president of the olde Hide House, said he would prefer not to comment on any arrangements the company may have with the town about the property until the transaction closes.

Capital works that King said would likely be done on the property include the removal of a fence and concrete loading dock. A portion of the property includes train tracks which King said would also be removed.

Soil tests would also have to be carried out Regarding whether or not the olde Hide on the property before the purchase is final.
