# No trial date set yet 873-0933 in Pomeroy case

It remains to be seen when Halton regional chair Peter Pomeroy will stand trial on corruption-related charges.

The regional council head appeared in Milton general division court Tuesday to set a trial date, but the task was postponed to September 1 due to scheduling problems.

Brian Greenspan (Pomeroy's lawyer), attorneys for the four coaccused, and Crown Attorney Brian Gover were unable to agree on a date when everyone was avail-

A representative of Greenspan's office told the court Pomeroy wished to start the trial at the earliest possible date because he holds public office.

It was also revealed that Pomeroy has decided to stand trial by judge alone, rather than judge and jury as earlier indicated.

The regional chair is charged with two counts each of breach of trust and accepting a secret commission.

Also facing trial in connection with the same incidents are his wife, Halton deputy clerk Pat Crimmins, Halton Hills

lawyer Bert Arnold and developer Ab Tennant.

At least two trials are expected to result from the charges, one involving Pomeroy, his wife and Arnold. Another trial will include all the accused. The lengths of the trials are expected to range from four days to four weeks.

Charges were laid against Pomeroy and the other last year after more than two years of investigation by Project 80, a joint forces police team established to probe allegations of municipal government corruption.
