Thank you for the opportunity to respond to Wednesday's editorial.

Because many Ward 2 residents do not receive cable television coverage of council and committee meetings each week, we rely completely on The Independent/Free Press for factual, unbiased report-

I respect your paper's right to state its opinion with respect to the candidates in Monday's election but I believe I have represented the residents of Ward 2 with distinction during the past three years. I have chosen not to continually seek credit for my accomplishments because I felt sure that the residents of this vast ward (you are right on that point) would acknowledge my efforts on Election Day.

When I was first elected three years ago, we were threatened with the possibility of a landfill on our border with Peel Region with three potential sites targeted. As council representative I personally worked long and hard negotiating to stop the dump. We were successful.

Because I believe our unique environment needs protection, I

actively supported the establishment of a Town Environmental Advisory Committee.

The concerns which continue now for Ward 2 residents are water, roads, rural subdivisions, prestige industry in the 401 industrial corridor, and taxes that are too high.

Our rural residents are experiencing water problems. Any solution to Halton Hills' current water requirements cannot result in any deterioration in the quantity and quality of the rural water supply. I have been involved in the study of this complex problem for the past three years and it is vital that I be allowed to continue to work to protect our rural water.

More development in Halton Hills brings increased traffic on the rural roads. Our roads must not be allowed to deteriorate and existing funds need to be re-allocated for rural road improvements and upgrades. My experience in this issue will be needed in 1995 when we do a new Transportation Study.

The new Region of Halton Official Plan does not permit rural subdivisions. It is my intention to defend this new policy so that rural

residents can feel less threatened. I strongly supported the study for the 401 Industrial corridor with the requirement that we attract prestige industry. We must attract new industry to the town. This study will be available within a few weeks and your comment will be crucial.

I worked to open up the budget process and to hold the line on taxes for the last three years. Of every municipal tax dollar collected, 59.2 cents goes to education and 13.9 cents goes to the Region of Halton. So the Town only received 26.9 cents and as a town councillor I have the responsibility to spend these funds

There are critically important issues facing Ward 2 residents. Of course there are the day to day concerns of the residents that I will continue to go to bat for.

I believe my experience, knowledge and the fact that I am able to devote a full-time effort on behalf of Ward 2 residents means that, if I am re-elected, they will be well represented.


This letter is in response to your insight into the needs of many called experienced councillors are be the first to throw in the towel. I, however, feel differently.
