

Due to the fact there was a 23vote difference in the Ward 2 local race between Kevin Kuiack, Kathy Gastle and Rob Heaton, Kuiack is not eligible for a recount.


Assistant returning officer Dorothy McDonald said according to the guidelines outlined in Section 91 of the Elections Act, based on the number of voters and polling stations in the ward, Kuiack would only be eligible for a recount if there was a 10-vote difference. Kuiack received 1,178 votes and Heaton and Gastle tied for first place with 1,201 votes each. Kuiack indicated after the unofficial results Monday night he planned to request a recount.

Thursday Kuiack voiced his disappointment he wasn't eligible for a recount.

"I don't think it's fair in this

said case," Kuiack. there was a miscount there is no way of knowing." Kuiack said

he has received hundreds calls phone since Monday night from residents in his ward upset


about the outcome. "They just can't believe nothing is being done."

McDonald said while Kuiack isn't eligible for a recount an elector can ask for one in front of a judge by way of an affidavit, based on reasonable grounds.

She cited reasonable grounds as votes being improperly counted, any ballot being improperly rejected, an incorrect statement of the number of votes being made, or improperly counted votes.

The elector has 30 days after the official results of the election are released to take the matter to court at a cost of \$100. Election returning officer Janet Lunn Stewart, also the town clerk, said she was not aware of any problems.

"All the deputy returning officer's statements balanced," said Lunn Stewart. "I am extremely confident the conduct of the election was proper and all ballots were accounted for properly."
