CRC ready for the next step

The Concerned Residents Coalition (CRC) is determined to ensure that there are no unacceptable impacts as a result of the proposed Hidden Quarry at Highway 7 and 6th Line between Rockwood and Acton. While Doug Tripp, of the CRC, explains that the group is not necessarily out to put a stop to the quarry, the impacts to safety, the environment and the quality of life for residents are likely insurmountable.

"The CRC is a community organization that represents not just Guelph, Eramosa and Rockwood, but Acton, Halton Hills and Halton," Tripp explained.

Formed in March of 2013 with approximately 20 members meeting around kitchen tables, membership has since grown to nearly 800 people drawing from all of the above mentioned communities. The CRC has incorporated as a not for profit organization, with a board made up of fourteen people.

The organization's concerns are many. They range from issues of safety, to environmental concerns, to issues with the haul route.

"Some residents, especially those in Acton, see the 26 large gravel trucks per hour 10 hours per day rumbling along a busy Highway 7 and through the downtown as a major upstream or downstream of the site are concerned about the impact on water quality and quantity in their wells, wetlands and streams. Many have become aware of the risks related to blasting, both in terms of fly-rock ejection onto Highway 7 and those residences and out buildings that are within several hundred metres of the site," Tripp explained when asked why the issue of the quarry was important to people. "Increasingly residents are recognizing that the end game is not one quarry, but rather that this quarry will be the thin edge of the wedge as other properties on the same rock formation become quarry candidates. And, I believe that the many residents who are following this case are not persuaded by the applicant's "trust us, everything will be fine" assurances."

The CRC has gone through great pains and expense to arrange for their own studies regarding these concerns, and don't feel that the proponent of the Quarry, James Dick Construction Ltd., has provided a satisfying response to these issues.

Presently, James Dick Construction has an application before the township of Guelph/Eramosa to rezone the land from agricultural. If the township approves the application,

problem. Some who live the CRC will appeal the decision to the Ontario Municipal Board. However if the township doesn't approve the application, it is likely the proponent will appeal. Either way, taking the matter to the municipal board appears to be the inevitable next step.

With that next step, the CRC will be facing significant expenses and are currently involved in an intensive fundraising effort.

Should the worst happen and the quarry is ultimately approved, the CRC will monitor the impact of the quarry, but Tripp admits that they will have a tough time making an impact at that stage.

Conversely, should the CRC be successful in stopping quarry, Tripp says there hasn't been time to consider what the CRC's function would be. He personally hopes, however, that CRC will continue to be a voice for environmental protection in the region.

Tripp expressed gratitude to the Town of Halton Hills, stating that the CRC appreciates the support and efforts of Mayor Rick Bonnette and Halton Hills Council-who recently voted to maintain the town's objection to the proposed quarry.
