11:41 a.m. Fire fighters responded to the report of a possible grass fire in the area of Greenore Cr in Acton. Fire staff searched the area and were unable to locate any fires and cleared the scene.

Monday, May 23

11:17 p.m. Fire fighters responded to a burn complaint with a strong smell of burning plastic, on Orville Road in Acton. On scene fire staff checked the area with no odour noticed.

Saturday, May 28

At 3:59 p.m. Fire fighters responded to the report of a two-vehicle motor vehicle collision in the area of Regional Road 25 and 32 Sideroad. Halton Regional Police and ambulance was on scene upon arrival. No extrication was required. Fire staff disabled the vehicles and cleared the scene.

9:26 p.m. Fire fighters responded to a burn complaint on Mill St W in Acton. On scene staff met with the tenant who did not have a valid burn permit. The fire was extinguished and the burn permit process was explained.

Female assaults 6 year old child

On May 29, at approximately 6:45 p.m., a female party attended the Walmart store located in the Town of Georgetown. The female proceeded to the front entrance area where she located a 6 year old female child and violently grabbed the child's hair and forcefully threw her to the ground. The child's face hit the ground causing her tooth to dislodge from her mouth.

The female attacker then continued

through the store assaulting four additional persons.

Police attended the store and were successful in arresting the female attacker.

A 39 year old of Georgetown woman was charged with one count of Assault causing bodily harm and four counts of Assault. She was held for a bail hearing scheduled for May 30.

At this time the motivation for this behaviour is still unknown.

POLICE REPORT

Trafficking Cocaine and Marihuana

On May 26, the Halton Police executed a Controlled Drugs and Substances Act search warrant at a residence on Cooke Crescent in Milton. The search warrant stemmed from an investigation regarding a cocaine and marihuana trafficker believed to be operating out of his residence.

Shortly after 2 a.m., the Drug Unit and the 1 District Street Crime Unit executed the search warrant. Upon entry, officers located 22 pounds of vacuumed sealed marihuana, one ounce of cocaine, and over \$16,000 cash. Officers also seized a variety of prescription medication including hydromorphone, oxycodone, and Adderall. The estimated street value of the drugs seized is \$45,000.

A 40 year old man and his 25 year old step-son were both arrested during the search of the residence.

The father was charged with:

- · Trafficking cocaine
- · Trafficking marihuana
- Possession for the purpose of trafficking cocaine
- Possession for the purpose of trafficking marihuana
- Possession of a controlled substance (Adderall)

The son was charged with:

- Possession for the purpose of trafficking cocaine
- Possession for the purpose of trafficking marihuana

Both were held into custody pending a bail hearing on May 26 in Milton
