As the first bank in Halton County, the Bank of Hamilton opened in December 1875 on Main St., opposite Knox Presbyterian Church. In 1890, it moved to the heart of Georgetown's downtown, 67 Main St., S. In this 1920 photo, it was located at the northwest corner of Mill and Main Sts. The Bank of Hamilton was taken over by the Canadian Bank of Commerce in 1923, which in turn, merged with Imperial Bank of Canada to become the present day CIBC in 1961.

Halton remains a hotspot for employment construction.


