The Way We Were



Built in 1863, Bennett House Hotel catered to the needs of visitors travelling to Georgetown for a half century. Located at 78 Main St. S., it featured 28 well furnished and comfortable bedrooms, a dining room, three spacious sample rooms for the use of commercial men, with a large bar room connected to the hotel. At the time of this 1913 photo, rates were \$1.50 per day, incredible by today s standards. The Cellar Restaurant now operates from this location at the corner of Main and Mill.

Seniors may qualify for property tax deferral help

On July 1, 2016, the City of Burlington, Town of Halton Hills, Town of Milton and Town of Oakville will begin accepting applications for Halton Region's Older Adults Property Tax Deferral Program. Serving residents throughout the community, this new program offers extra financial support for older

It will be offered by each City or Town to older adult homeowners with low incomes in their community. The program allows participants to defer the full value of their annual property taxes, interest free, helping them manage the rising cost of living.

This will make home ownership more affordable and help participants focus their limited financial resources on their dayto-day needs.

If you are eligible, just one application form submitted to your Local Municipality is all it takes to join.

The deferral establishes an interest-free loan that you can repay at any time, and to stay in the program, you simply need to submit a renewal form each year. We worked with the Local Municipalities to keep the program straightforward and supportive, allowing its participants to focus on their busy lives and
