New Show at Red Door Gallery: Missed Me, Missed Me

Massive canvases, personal and political struggles, and the gritty side of Havana, Cuba, all typify the work of Doug Pattison.

Pattison was born in Mississauga in 1961 and started painting at the age of 12. He studied at numerous art colleges including Three Schools of Art, Toronto, Banff School of Art, Alberta, and Ontario College of Art in Toronto. Producing paintings, sculpture and mixed media, he showed his work 1975-1983, in one man and group shows, including The American Art Gallery in Bern, Switzerland, Gallery Moos in Toronto. His success culminated in a feature exhibition at the Art Gallery of Hamilton.

By anyone's standards he was a highly talented, hard working and promising young artist. But at the age of 24 he stopped painting; raising a family and establishing a building business left no time for professional art practice. He didn t pick up a brush until 20 years later, after the death of his brother in 2009.

His later work, both painting and mixed media, is assured and fluent, and empathetic about the lives it depicts. Themes of love, deception, family ties, loss and redemption permeate and sometimes saturate the work.

A recent move from acrylic to oil paint brings light that has sometimes evaded Pattison's own life. Doug Pattison will be present in the gallery Oct. 1 from 10 a.m. to noon to talk about his work as part of Culture Days, a national three-day event devoted to providing Canadians with opportunities to participate in, and appreciate, all forms of arts and culture. Town of Halton Hills Heritage Register Phase 4 Initiation haltonhills.ca



Council for the Town of Halton Hills wishes to inform all residents and business owners of a process that the Town is undertaking to identify properties of heritage value by listing them on the Town's Comprehensive Municipal Heritage Register. The intent of listing properties on the Town's Heritage Register is to serve as a heritage conservation tool, in accordance with Section 27 of the Ontario Heritage Act. If the property owner of a listed property ever applies for a demolition permit, the Town may delay the issuance of a demolition permit by up to 60 days, which provides the Town with enough time to further review the heritage value of a property prior to demolition.

The Town's Heritage Register is being completed through four distinct phases. Phase 1 was completed in June 2010, Phase 2 was completed in April 2013, and Phase 3 was completed in June 2016.

The Town is now initiating Phase 4 of the Heritage Register, which will be the final phase of the Town's Comprehensive Municipal Heritage Register initiative. All property owners whose properties are being considered for inclusion in Phase 4 of the Town's Heritage Register will be individually notified in writing and invited to a public open house to receive more information.
