Acton's Nurse Practitioner: Just what over-worked doctors and patients needed

Ten years after the province began funding Nurse Practitioner (NP) programs in Ontario, Roger Firsoff, Acton's first and only NP, continues to provide better health care access to patients at the Acton Medical and Urgent Care Centre.

Firsoff began seeing patients in Acton in 2005 when Acton was deemed "under-serviced" for family physicians by the province. Acton's three doctors were often triple booked, and one limited office visits to just one issue because so many people needed to be seen. That's in sharp contrast to today's provincial health care model with NPs, like Firsoff, doing physical exams, ordering tests for diagnosis and recommendations for a wide range of acute and chronic diseases, and providing treatment, including prescribing required, and can refer pamedications.

Firsoff sees approximately 2,000 patients annually; all who are "rostered" to one of the four doctors in a Family Health Organization at the Acton facility. At least once a day, a patient thanks him for taking so much time during their visit, which often last 30 minutes.

"Sometimes it's tempting to maybe reduce the time spent with patients that I see - more volume but when you get those comments, you appreciate the time you spend with each patient," Firsoff said last Tuesday.

He said if he is presented with a medical issue that he doesn't have the knowledge, skill or judgement to deal with, he consults with the doctors, and can transfer patients to a doctor's if


tients to specialists.

As an independent contractor, Firsoff is paid by the Ministry of Health which provides \$120,000 annually, an amount frozen for the past four years. Firsoff said if it weren't for Halton's Physician Recruitment Officer, Angela Sugden-Praysner, and the Town's Economic Development Officer Doug Penrice, Acton would not have a Nurse Practitioner, as they helped secure an additional \$7,500 annually for his practice from both Halton Region and Halton Hills.

Halton Physician Recruitment Officer Angela Sugden-Praysner said Firsoff offers "value added" health care, including home visits and education programs.

the beginning of the NP program because it required a new relationship between doctors and NPs, Sugden-Praysner said the position has "evolved because Acton is kind of a unique setting, and the need to have some extra help in that clinic, he's been able to do a number of different things to help

the patient population," she said.

Sugden-Praysner said the program's success in Acton is due to the collaboration - and acceptance of the new model of family medicine by Acton's doctors, including Dr. Nather Alshakarji. "The (Nurse Practitioner) program helps patients,

staff and doctors, when we are away and busy. The (patient) load in the Town is too much," Dr. Alshakarji said, adding that will ease with the recent arrival of Dr. Nina Nahab who will be seeing patients and walk-ins by the end of the month at the Acton Medical and Urgent Care Centre.
