An unidentified fast food outlet with a dining component is in the "final stages" of negotiating to lease half of one of two buildings in the Honeyfield Plaza at the south-west corner of Queen Street and Tanner's Drive, currently home to a gas bar/kiosk.

Alfio Manarin of Rinarin Developments, whose father bought the Acton property more than 35 years ago, earlier called the plaza the eastern gateway to Acton. "This will be a class A retail plaza at a premium location" Manarin said on Tuesday, ary" plaza at the eastern end of Acton. And just who may be coming to Acton? Manarin would not say,

except to identify the potential tenant as a "larger retailer" who is new to Acton who would take half of the smaller 2,800-square-foor building. He said they would likely wait until they have a tenant lined up to begin construction of the larger building, approximately 10,000-square-feet. "But, we been pleasantly surprised with the interest we've received to date by both new tenants looking to service the Acton community and existing retailers that are looking to upgrade their space,' he said.

Allowed uses include a business office, convenience store, gas bar, and bank, printing establishment and retail store. Not allowed are a car wash, personal care store, private club, day nursery, fitness centre, restaurant or medical, dental or drugless practitioner's offices.

Halton Region named top municipal electronics recycler

Halton Region has been named as a top municipal electronics recycler in the tournamentario Electronic Stewardship (OES) for working with residents to divert electronic waste away from the landfill. A total of 483,080 kilograms of unwanted electronics was collected at the Halton Waste Management Site in 2012.

Halton Region has offered e-waste recycling to residents since 2002 and then partnered with OES in April 2009, allowing the Region to make the recycling of e-waste more convenient for residents by providing a free recycling location for e-waste at Halton Region's land-

"Being recognized by OES as one of their top municipal electronics recyclers is a reflection of our community's commitment to Halton Region's waste diversion programs

and the protection of the environment," said Gary Carr, Regional Chair. "Halton residents are among the best in the province when it comes to participating in recycling and composting programs. Their efforts keep waste out of the landfill and help to extend the life of this very valuable resource four more years--a savings of \$15 million for taxpay-
