## Evidence recovered in Acton leads to arrest in Kawartha Lakes murder

## Accused helped maintain the Blue Springs Scout Reserve west of Acton

to arrest and charge a Kawartha Lakes man with the first degree murder of his wife was seized in Acton following a 12-hour search of the Acton Scout House on School Lane last Thursday.

On Friday, September 27 at 8:50 a.m., Kawartha Lakes OPP found the body of Wendy Taylor, 59, the victim of a "homicide of domestic nature," according to OPP spokesman Sergeant Peter Leon who said the investigation con-

The Taylor's name is well-known in Scouting circles - the couple were recipients of Silver Acorn awards, the highest Scouting award, and Iain Taylor was a volunteer who helped maintain the Blue Spring Scout Reserve on the Sixth Line, Nassagaweya. It was also searched by the OPP last Thursday, but Sergeant Leon did not believe any evidence was seized at that location.

Sergeant Leon said in-

Evidence that led OPP formation led police to Acton, where "through the course of investigation they were able to locate evidence pertaining back to that (homicide) investigation," he said on Monday, adding the evidence - he would not say what - "greatly assisted" in their investigation and led to arrest Iain Taylor on Sunday morning in Peterborough.

> John Petitti, Executive Director of Marketing and communications at Scouts Canada said Taylor has been suspended from Scouts Canada. He said Taylor had been a member of the Baden Powell Guild, retired Scouters who remain members of Scouts Canada. Taylor was involved in maintaining Scout camping facilities Petitti said, but did not work with youth as part of his volunteer activities.

Officers with the OPP Urban Search and Rescue Team with two specialized vehicles based in Bolton searched the Scout Hall and adjacent grounds.

At press time, Taylor was held in a Lindsey jail awaiting a bail hearing. Funeral services will be held for Wendy Taylor tomorrow (Friday) in Hampton, Ontario.
