

P&H Milling has until tomorrow (Friday) to install silencers at its Acton facility to comply with a Provincial Officer Order to control noise.

A deluge of noise com-

plaints from frustrated neighbours prompted the Order, which set deadlines for the Mill to identify and install noise reducing equipment and practices. On Friday, Tina Dufresne, Ministry of En-

vironment District Manager, said P&H was on schedule to install silencers and lagging – insulation around pipes to

control the noise.

Once the ordered work is complete, P&H must conduct an acoustical audit to see if

the mill is in compliance with provincial noise limits of 50-decibels during the day, and 45-decibels at night.

Mill Neighbour Peter Duncanson questions if the work will be done on time,

noting on Tuesday morning that nothing had been started. "We're willing to give them the benefit of the doubt, but unless a crew of millwrights arrive today or tomorrow, they won't meet the deadline."

# It's Our Own Garbage

## What We Did in 2010

By participating in Blue Box, GreenCart, yard waste, reuse and household hazardous waste programs, Halton residents are sending less garbage to the landfill.

In 2010, the overall waste diversion rate remained constant at 57.4 per cent. This rate applies to all waste material managed by Halton Region through our programs and services. It is important to note that 60 per cent of household waste (i.e. Blue Box, GreenCart, Yard Waste, Metal, Backyard Composting, and Grasscycling) was diverted from landfill in 2010. This is one of the highest residential waste diversion rates in Ontario! Thank you Halton residents!

## Joint Municipal-Regional Waste Management Committee

The Committee was established as a Condition of Approval for the Halton Waste Management Site when it opened in 1992. The Committee advises Halton Region Council regarding programs and strategies to promote the 3Rs—reduce, reuse, recycle to minimize the amount of waste going to the landfill. The Committee is comprised of members from Burlington, Halton Hills, Milton and Oakville.

In 2010, the Committee reviewed Extended Producer Responsibility programs, explored multi-residential recycling opportunities, and guided the development of the Draft Solid Waste Management Strategy, including providing a vision for Halton to remain a leader with respect to waste reduction and diversion.

## The Results

Total material diverted from landfill through reuse, recycling and composting programs: 122,467 tonnes

Amount of materials collected at the curb, events and Halton Waste Management Site:

- Blue Box: 48,195 tonnes
- GreenCart: 26,786 tonnes
- Yard waste: 31,987 tonnes
- Household hazardous waste: 860 tonnes (from over 43,312 vehicles)
- Electronic waste: 581 tonnes

Total garbage landfilled at the Halton Waste Management Site: 74,327 tonnes (lowest amount of garbage landfilled in a single year since the site opened in 1992). Visit [www.halton.ca/waste](http://www.halton.ca/waste) to read Report PW20-11 for more information on Halton's waste diversion results.

## What's Next

Halton Region is exploring ways to further increase residential waste diversion to 65 and even 70 per cent! In consultation with the Joint Municipal Regional Waste Management Committee, Halton Region has developed a Draft Solid Waste Management Strategy. The Draft Solid Waste Management Strategy identifies 11 potential initiatives that could be implemented to achieve these higher waste diversion goals. The final updated Strategy will be completed in fall 2011 incorporating feedback from open houses and surveys conducted in spring 2011.
