#### Miss Congeniality



My husband and I have made various complaints and voiced our concerns regarding the damage being done to our property and our cars but those messages seem to have been ignored or lost by various officials. The writer only stated some of the concerns that they have; however, I can confirm that we have incurred damage to our vehicles

and our house during this work to which no one seems to want to accept responsibility. This is primarily because our house is directly on Doctor Moore in the middle of the construction. We have not even been able to open our windows due to the amount of dirt coming into our house and ultimately covering our house externally. Our cars have suffered tire and stone damage from the various phases of construction and we have not been able to use either our porch or deck for the full period to date.
