### TOWN-INITIATED OFFICIAL PLAN AMENDMENT ADDRESSING MINOR REVISIONS TO THE OFFICIAL PLAN

Halton Hills Council invites you to attend a Statutory Public Meeting to discuss a proposed Official Plan Amendment addressing minor revisions to the Town's Official Plan. The purpose and effect of the proposed amendment is to make minor revisions to the Official Plan, to predominantly address inconsistencies in section numbering and formatting, without altering the intent or effect of the policies or schedules (maps) of the Official Plan. This amendment applies generally to the entire municipality, so a location map has not been provided.

Following the statutory public meeting, Town staff will prepare a report to Council that will respond to oral and written comments received, and provide a final recommendation of the proposed Official Plan Amendment.

The draft amendment will be available for public review and comment at the Town of Halton Hills Planning and Infrastructure Department and on the Town's website at <http://www.haltonhills.ca/officialPlan/pdf/OfficialPlanAmendmentNo26.pdf>.

**Please note:**

1. If you wish to be notified of the decision of the Town of Halton Hills regarding the Official Plan Amendment, you must make a written request to the Town of Halton Hills Planning and Infrastructure Department at 1 Halton Hills Drive, Halton Hills ON L7G 5G2.
2. If a person or public body does not make oral submissions at a public meeting or written submissions to the Town of Halton Hills before the Official Plan Amendment is adopted, the person or public body is not entitled to appeal the decision of the Town of Halton Hills to the Ontario Municipal Board.
3. If a person or public body does not make oral submissions at a public meeting or written submissions to the Town of Halton Hills before the Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board, unless, in the opinion of the Board, there are reasonable grounds to do so.
4. Any written submissions to the Town of Halton Hills regarding the Official Plan Amendment may be made public as part of the process.
