WHAT IS A CONJUGAL SURV? (Part 1)

A conjugal survivor's annuity is a benefit payable to the surviving spouse of a deceased member of a registered pension plan. The annuity is payable for the remainder of the surviving spouse's life, or for a term of years, or until the annuity is exhausted. The annuity is payable to the surviving spouse if the deceased member was a member of the plan at the time of death and was entitled to a conjugal survivor's annuity at the time of death.
