



Counter-intuitive changes proposed for Canada's fastest growing community

Milton council. in a six to five vote last year, opted to go with a smaller council ahead of the 2018 election. After requesting and finally getting two more regional councillors, the decision was made to decrease council from eleven to nine: four local and four regional councillors plus the mayor, along with a plan to reduce the number of wards from eight to four, with the final configuration voted on at the December 12 meeting.

The option chosen would add a portion of the rapidly growing urban area of Milton to the predominantly rural part of the town. For Ward 3 residents, which is comprised of a uniquely rural and culturally distinct area formerly known as Nassagaweya Township, there are concerns that sharing just one local councillor and a regional councillor with a considerably denser chunk of the urban area threatens to not merely water down the rural voice, but potentially drown it out completely.

Ward 3 councillor Cindy Lunau said the six who voted in favor of 'option B' cited cost savings as

a reason, along with a simplification of ward boundaries. But out of four possible schemes presented by consultants hired by the town, Dr. Robert Williams of Watson/Williams recommended the one that would best preserve the rural area.

"Council went against t h e consultant's recommendation," Lunau said. Despite over 110 responses wanting anything but option B. "It splits the downtown area, and splits a neighborhood. And the population will overwhelm the rural voice." Those in favour say splitting it into four quadrants makes it easy to understand, but in Lunau's opinion, it

The obvious upshot is that by 2018, while all councillors must vie for re-electionjust like a bad game of musical chairs-there will be four less chairs to have a shot at.

The decision is a done deal unless appealed to the OMB by the January 26 deadline. This decision compounds the already declining goodwill of rural residents toward council after last year's decision to even up the tax She also pointed out rate between urban and rural residents. As the rural voice loses value, Lunau 3, but will now get recalls the town's old motto, "best of town and country," noting wryly, "it's quickly becoming best of town only."
