TAKE NOTICE that the Council for the Corporation of the Town of Halton Hills enacted By-law 2016-0070 on December 12, 2016, in accordance with Section 17(23) of the Planning Act, to adopt Amendment No. 26 to the Town of Halton Hills Official Plan.

AND TAKE NOTICE that any person or agency who objects to all or part of By-law 2016-0070 may appeal to the Ontario Municipal Board (OMB) by filing a Notice of Appeal with the Town Clerk no later than 4:30 p.m. on January 11, 2017. The Notice of Appeal must set out the reasons for the appeal, and be accompanied by a fee of \$300.00 (certified cheque or money order) made payable to the Minister of Finance. If you wish to appeal to the OMB, an appeal form is available for download from the OMB website at www.omb.gov.on.ca. Only individuals, corporations, or public bodies may appeal a by-law to the Ontario Municipal Board. A Notice of Appeal may not be filed by an unincorporated association or group, however, a Notice of Appeal may be filed by an individual on behalf of an unincorporated association or group. Official Plan Amendment No. 26 is exempt from approval by Halton Region. The decision of Halton Hills Council is final, if a notice of appeal is not received by 4:30 p.m. on January 11, 2017.

PURPOSE AND EFFECT OF OFFICIAL PLAN AMENDMENT NO. 26:
The purpose and effect of the amendment is to make minor revisions

to the Official Plan, to predominantly address inconsistencies in section numbering and formatting, without altering the intent or effect of the policies or schedules (maps) of the Official Plan. These revisions were identified through an Official Plan Consolidation process, and are necessary to maintain the clarity and usability of the Official Plan. Official Plan Amendment No. 26 applies generally to the entire municipality, so a location map has not been provided.

Copies of the Official Plan Amendment are available on the Town's website at <http://www.haltonhills.ca/officialPlan/pdf/OfficialPlanAmendment26.pdf>, or at the Planning and Infrastructure Department at the Town of Halton Hills Civic Centre, from Monday to Friday, between 8:30 a.m. and 4:30 p.m. Note: The Civic Centre will be closed from 12pm on December 23, 2016, to 8:30am on January 2, 2017.
