10 charges laid after single-car crash

A Toronto man is facing several charges, including impaired driving, stemming from a single motor vehicle collision that occurred more than three months ago.

Halton Regional Police reported that on Saturday, Sept. 17 just before 3 p.m., officers were dispatched to the area of Hwy. 25 south of 10 Sideroad and located a 1997 white Toyota Avalon off the roadway.

Officers observed that the man had a badly injured right forearm and assisted the suspect in receiving treatment from Halton Emergency Medical Services on scene.

The accused was placed under arrest for impaired operation of a vehicle minutes after the collision, but due to the extent of his injuries that

required hospitalization, he could not provide breath samples and was unable to understand a blood demand.

Police said the man was released unconditionally several hours later with the intent of issuing a summons at a later time for several charges.

Following an investigation that is ongoing, 49-year-old Robert William Wattam has been charged with impaired operation of a motor vehicle, having over 80 mg of alcohol in 100 ml of blood, breach of probation, three counts of driving while disqualified and four counts of driving while under suspension.

He was scheduled to be served with the summons for the above charges in Milton Provincial Court on Dec. 19.
