**BY-LAW NO. 2017-0010**

A By-law to grant a site specific exception for the property with the main part address of 183 Rowley Drive, Georgetown, to be exempt from Interim Control By-law 2016-000h.

**WHEREAS** on February 28, 2016, Council for the Town of Halton Hills enacted Interim Control By-law No. 2016-000h to control the erection of or additions resulting in any large scale any residential dwellings within defined areas of the Town of Halton Hills for a period of one year.

**AND WHEREAS** on March 21, 2017, Council for the Town of Halton Hills approved Resolution No. 2017-0010, dated March 4, 2017, which provides for the proposed amendment to the Interim Control By-law 2016-000h.

**NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:**

- Interim Control By-law 2016-000h, as amended, is hereby further amended by adding the following section:
- Newly amended Section 1 of this By-law, on the lands described as 183 Rowley Drive, Georgetown, there shall be permitted the construction of a two-storey dwelling resulting in a total Gross Floor Area of the principal building not exceeding 4,600 square feet.
