NOTICE OF PUBLIC MEETING DEVELOPMENT CHARGE BY-LAW

In October 2016, Halton Region began a consultation process for the 2017 development charges update. A Background Study has been prepared to propose a by-law that will replace the Region's existing residential and non-residential water, wastewater (Built Boundary and Greenfield Areas), roads and general services development charges in By-law No. 48-12.

The "2017 Halton Development Charge Background Study" for the Region's Development Charges By-law was made available to the public on **Wednesday December 14, 2016**, and can be obtained at the Office of the Regional Clerk at 1151 Bronte Road, Oakville, Ontario, L6M 3L1. The Study can also be accessed online at halton.ca/developmentcharges.

Public Meeting

The *Development Charges Act, 1997* requires that at least one public meeting be held prior to the passing of a development charges by-law. The purpose of this public meeting is to present the 2017 Halton Development Charge Background Study and proposed by-law and to allow persons to make representations relating to the proposed by-law.

The public meeting will be held by the Regional Administration and Finance Committee as follows:

All interested persons are invited to attend the public meeting and to make representations. The final proposal and by-law will be presented to the Administration and Finance Committee at its regular meeting on **Wednesday, May 10, 2017 at 1:30 p.m. in Council Chambers.**

The final by-law will be presented to Council for approval on **Wednesday, June 14, 2017, at 9:30 a.m. in Council Chambers.**
