Halton is home to some of the safest communities in each year we hear this from our local law enforcement officials vet we are not immune to violence, crime, and tragedy just as our community is not without poverty, mental health challenges, hunger and

In recent weeks, residents have been learning of numerous deaths in our community.

In early March, a call from a citizen brought police, then the homicide unit, to a luxury condo on Lakeshore Rd. W.

A week later, we learned Angela Skorulski, 56, had lost her life after being shot in her condominium apartment. Who shot her? Why? How did this happen?

All questions still unanswered. In fact, very little is known about Skorulski's death. Police released her photo, but few other details.

Last week, Oakville resident Ferdinand Mejilla (Dr. Fred), who operated a chiropractic office in neighbouring Burlington, died at his clinic of gunshot wounds. His alleged killer, Burlington resident David Williamson, 44, died last weekend of a self-inflicted gunshot wound sustained during the chiropractic office shooting. We do not know what happened.

Two weeks ago, Mississaugas Yusuf Ghanam, 23, went to work at a construction site in Oakville and did not return home. Ontario s Ministry of Labour is investigating the apparent collapse of a wall in relation to his death.

Three people died locally this month who had no reason to die senseless tragedy in our community.

Recently, this space looked at the ongoing fight against human trafficking, another blight on public safety and human dignity that is reportedly a significant issue locally.

What can we do? Lots. We can be vigilant for our friends, neighbours and families.

We can use the many local resources that exist to help in all types of struggles.

We can push for change for the better at the political level. We can keep eyes and ears open through our daily lives, to do our part in keeping our community, people,

The police found him just as the snow started and within hours, we had a freezing rain event.

The swift actions of the Halton Police certainly led to our happy ending.

Thank you to all of our friends, family and the Living Hope Alliance Church for your gathering around me with your support and prayers.

Thank you also for getting out there to search for Al and for sharing the information on your social media feeds.

Your supportive comments and personal messages online really helped and made me feel loved and supported.

He was chilled, tired, achy and suffering from shock, but at least he is now home safe with his family who love him.
