Chief praises Halton officers in wake of SIU decision

The province spolice watchdog has cleared a Halton police officer of any wrongdoing in the shooting of Grayson Delong last September.

At this time I wish to publicly commend each of our officers for the roles they played that day. They were able to effectively intervene in a rapidly unfolding, life-threatening incident, said Halton police chief Stephen Tanner in a release sent May 10.

While we may never know for sure, these officers quite possibly saved the life of the victim who had been shot. Following the initial incident, the officers rendered medical assistance at the scene until Toronto EMS arrived. he added.

Last September, an undercover Halton police officer shot 51-year-old Grayson Delong after police say Delong allegedly shot Toronto lawyer Randall Barrs outside his office on Bedford Rd. in Yorkville.

At the time of the incident, HRPS officers were following the suspect, as part of an ongoing property crimes investigation, wrote Halton police in its release.

Shortly after arriving in the city, Mr.

Delong suddenly and unexpectedly discharged a firearm and an individual suffered gunshot wounds. Officers intervened and, after a brief interaction, (Mr. Delong) was shot by police. Both the victim and Mr. Delong survived, added the release.

According to the Special Investigations

Unit (SIU), the provincial body called to investigate any incident involving police where someone is killed or injured, On Sept. 20 of last year, a team of undercover, plain-clothes Halton Hills officers were tasked with monitoring Delong, who was suspected of several property offences in Burlington.

The SIU report says officers began surveilling Delong at a scheduled 9 a.m. court appearance at Brampton court. The suspect was then followed to Admiral Rd. in Toronto where police said he exited the vehicle dressed as a construction worker and wearing a blond wig.

He then walked to a nearby park where he stayed for approximately one hour. Suspecting that Mr. Delong was preparing to

commit a robbery, the team contacted other area police services about their suspicions, wrote the SIU in its report, adding Delong then made his way to an office at 23 Bedford Rd. at approximately 3 p.m.

The subject officer, directed to approach on foot in order to ascertain if

> Mr. Delong was still inside the vehicle, saw Mr. Delong slouched down in the rear passenger seat. He was still wearing the disguise. The subject officer walked into the stairwell of a nearby building which afforded him a view of Mr. Delong sitting in the vehicle, added the report.

Police say Delong then exited his vehicle and allegedly shot Barrs with a semi-automatic pistol before getting

back in his vehicle.

The subject officer, now standing on the east sidewalk took out his gun and walked behind the vehicle Mr. Delong was in and pointed his pistol at it. The subject officer yelled, Police, police, police!.

Delong then allegedly tried to pull out of the parking space in a jerky motion, then stopped and once again discharged his weapon.

The report then claims the officer took aim and fired three shots as Delong began to drive down Bedford Rd.

The subject officer aimed his gun at the rear of Mr. Delong s vehicle and fired three times. After firing the third shot, he noticed Mr. Delong slump to the right, and his vehicle suddenly jerked and started rolling forward, said SUI investigators.

Upon closer investigation, officers determined Delong had been struck by two bullets and paramedics were called.

Both Delong and Barrs survived the incident and Delong was charged with 15 offences stemming from the alleged attack.

No police officer wants to be placed in a situation of having to consider, never mind actually using deadly force. However, we know from this and many other similar, serious cases across the country, it can be a requirement of our highly-trained and professional officers, said Tanner in the HRPS release.

With the SIU investigation concluded, I want to once again thank our officers for their actions and commend them for their professional conduct throughout the incident and resulting investigation, he
