

Road Safety campaign targets wayward drivers in Halton Hills

Some questionable excuses were being given by distracted drivers pulled over by Halton Regional Police (HRPS) Const. Jeff Sandifer during Canada Road Safety Week last Thursday.

Motorists in Halton Hills may have noticed a heightened level of enforcement during the weeklong campaign, which focused

on aggressive, impaired and distracted driving.

Halton residents have ranked traffic concerns as their No. 1 policing priority in surveys, so a team of eight officers from the HRPS's One District Response Unit is on the prowl for those offenders.

An *Independent & Free Press* reporter was invited to accompany Const. Sandifer on a ride-along for a couple of hours last week to experience what fellow officers encounter

on local-area roads daily.

While on patrol earlier that day in the area of Trafalgar Road and Steeles Avenue, Const. Sandifer said he administered three offences for operating a motor vehicle while using a hand-held communication device within the space of about an hour.

One woman driving a Cadillac Escalade caught talking on her cellphone pleaded with Const. Sandifer that because she was speaking with an unwell daughter at home,

that could be considered an emergency situation.

Another driver was observed by the officer typing away vigorously on his phone, but denied texting anyone while being handed his \$490 fine and subtracted three demerit points. The man said he was hungry and Googled the location of the nearest McDonald's Restaurant to get breakfast.

A Public Information Centre is being held on Tuesday June 6, 2017, for interested members of the public to present the background work that has been completed to date on the Trafalgar Road Redevelopment Area Comprehensive Development Plan (CDP). The CDP was initiated through an Information Report presented to the Community Affairs Committee on May 16, 2017.

The CDP Study Area is generally bounded by the CN Railway to the east, Trafalgar Road to the west and the Georgetown Christian Reformed Church and Halton Hills Christian School to the north. The CDP will guide the design and development of the lands to realize the intensification and sustainability interests of the Halton Hills community. The CDP will consider the following:

- Achieve density targets for the area;
- Sustainably service new development;
- Manage and enhance environmental features; and,
- Integrate land uses, physical connections, and trails.

The purpose of the Public Information Centre is to introduce the intent and objectives of the project to the community and obtain public input on the preliminary Development Concepts being completed for the CDP.

Please note this will be a drop-in format with a brief presentation on the background material and work completed to date to ensure participants are well-informed and able to engage in a meaningful discussion
