Mortgage vs Line of Credit

What is the difference between a mortgage and a line of credit?

A

It is amazing how often clients when selling their home indicate they have no mortgage. We then learn from the purchasers lawyer we must arrange to remove our client's mortgage registered on title.

When questioned our clients are confused and insist they have no mortgage. What they have is a line of credit and clients insist their bank never mentioned mortgage when they got this loan. This circumstance has happened so often I am of the opinion the bank is reluctant to tell their clients they are registering a mortgage.

An unsecured credit line is a loan from your bank where they count on your promise to pay it off. If you don't pay it back the bank can sue you to get their money. Often these are small loans.

A secured line of credit is a "mortgage" from your bank and if you don't pay the bank can sell your home to get their money back. When looking for a loan make sure you ask your banker whether the credit line will be registered against your home. If it is to be registered against your home, it is a "mortgage"
