

**NOTICE OF A PUBLIC MEETING

Part of Lot 15, Concession 5, Ward 2,
Town of Halton Hills, Regional Municipality of Halton
Town of Halton Hills File: D12SUB17.002
(10862 Steeles Avenue East, Esquesing)**

General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed application for approval of a Plan of Subdivision.

The proposed Plan of Subdivision applications apply to the lands legally described as Part of Lot 15, Concession 5, Town of Halton Hills, Regional Municipality of Halton. The subject lands are municipally known as 10862 Steeles Avenue East (Esquesing). Below is a map showing the location of the subject property.

The purpose and effect of the application is to allow for the creation of three (3) commercial development blocks, a public road, and a stormwater management block.

If you wish to be notified of the decision of the Town of Halton Hills in respect of the Plan of Subdivision application, you must make a written request to the Town of Halton Hills – PLANNING & SUSTAINABILITY DEPARTMENT at 1 Halton Hills Drive, Halton Hills, Ontario L7G 5G2.

NOTES:

1. If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the application is

passed, the person or public body is not entitled to appeal the decision of the Town of Halton Hills to the Ontario Municipal Board.

2. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Halton Hills before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
3. Any written comment/objection submitted to the Town of Halton Hills regarding this application which is being processed under the Planning Act 1990, may be made public as part of the application process.
